FOREWARD

Public Law 93-400 requires that the Office of Management and Budget (OMB), Office of Federal Procurement Policy (OFPP), “...establish a system for collecting, developing, and disseminating the procurement data which takes into account the needs of the Congress, the executive branch, and the public sector.” Under the guidance of OFPP, design of the Federal Procurement Data System (FPDS) was completed in early 1978 and data collection began October 1, 1978. The Federal Procurement Data Center provides a central point to respond to the requirements of the legislative, executive, and judicial branches of the Government as well as the private sector.

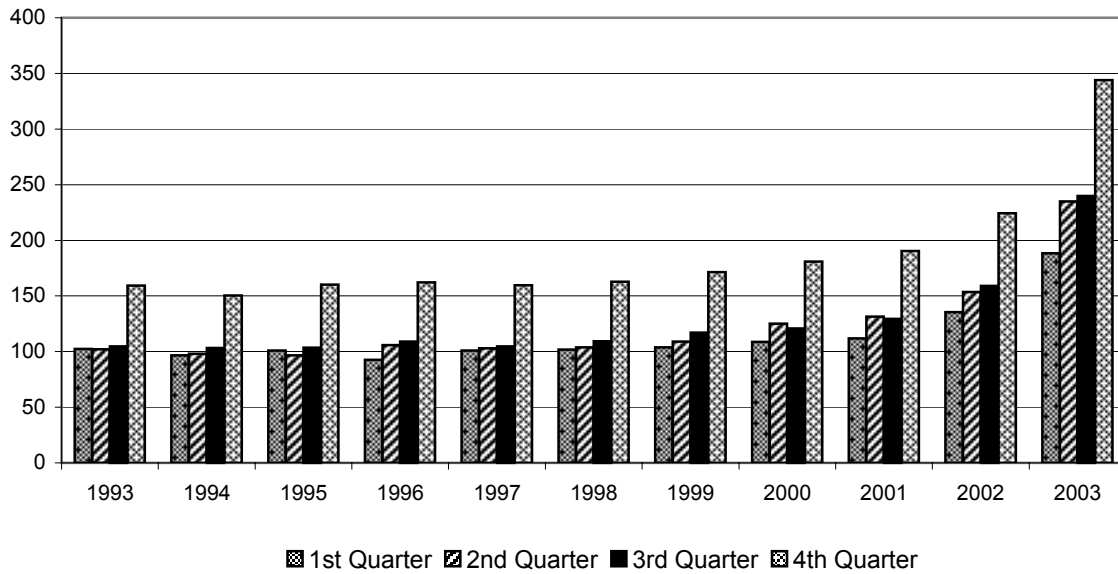
Beginning October 1, 2004 Global Computer Enterprises, Inc. became the owner and operator of the Federal Procurement Data System – Next Generation (FPDS-NG) for FY 2004 data and subsequent fiscal years. Historically the Federal Procurement Data Center produced reports that examined the various aspects and impacts of the Federal acquisition process. Now this information is available through the enhanced reporting capabilities of the FPDS-NG. This data can be used for geographical analysis, market analysis, and analysis of the impact of congressional and presidential initiatives in socio-economic areas such as small business. The data is also a reliable basis for measuring and assessing the impact of the Federal acquisition policy and management improvement.

Special reports to meet specific data requirements re available through GCE’s reporting system. Basic acquisition data will be published electronically each fiscal year providing the same types of data available in past years through the Federal Procurement Report. Reports will be available on GCE’s Web Site <https://www.fpds.gov>.

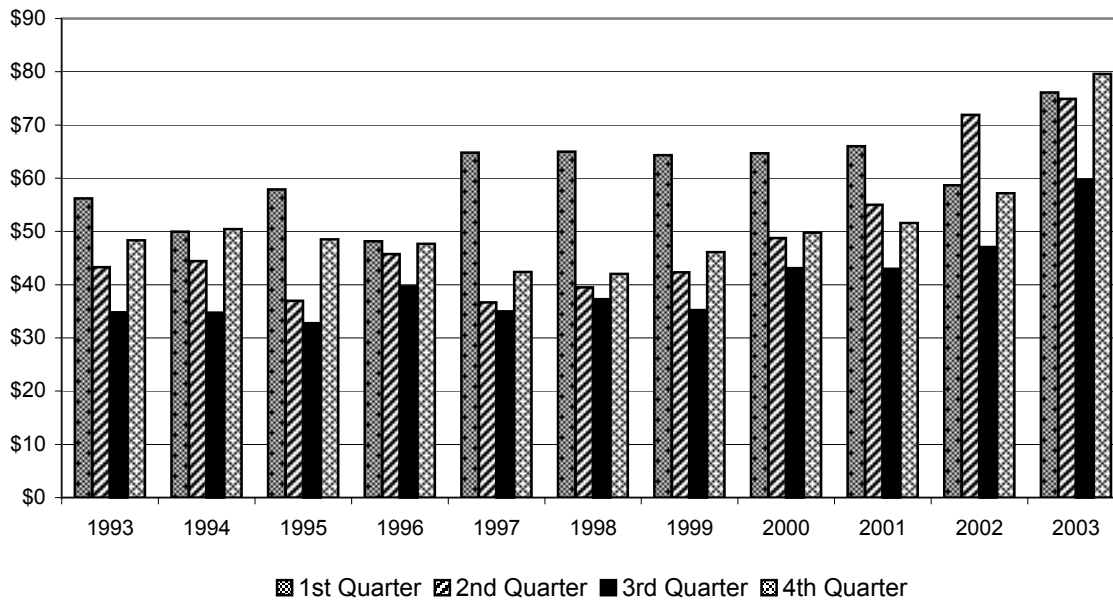
FEDERAL PROCUREMENT DATA SYSTEM

FEDERAL PROCUREMENT DATA SYSTEM (FPDS)

HIGHLIGHTS

The FPDS Federal Procurement Report is developed annually, and contains "snapshot" statistics on the procurement activities of over 50 agencies. The figures in this report are only as accurate, timely, and complete as the data provided by the reporting agencies to the FPDC.

Fiscal year 2003 is the first year that the agencies reported in whole dollars. In order to avoid reformatting this report, each action was rounded to the thousands. Two agencies that reported, **US Soldiers and Airmens Home** and the **National Transportation Safety Board**, are not displayed because each of their actions were less than \$500 and their actions rounded down to zero. All dollars are in thousands except for the dollars in the Credit Card Report and the per capita procurement displayed at the top of each State Snapshot. Due to rounding, dollars on the charts may not equal the TOTAL DOLLAR figure, and percentages may not total 100 percent. The Report on Annual Procurement Preference Goaling Achievements figures may not match the figures in the agency snapshot reports due to a variety of exclusions.

The **Federal Communications Commission, Federal Labor Relations Authority, Federal Mediation and Conciliation Service, Federal Mine Safety and Health Review Commission, Merit Systems Protection Board, National Capital Planning Commission**, and the **Occupational Safety and Health Review Commission** did not report in fiscal year 2003 and are not displayed in this report.

The data used to compile this Federal Procurement Report is current as of 4/12/2004 and all older reports are obsolete, therefore, the FPDC will not maintain prior issuance for either distribution or for reference. This report is in addition to the other selected reports for FY 2003 that are on this web page. Those prior selected reports differ because they were generated based on funding agency and this report is based on the awarding agency.

In FY 2003 a contract was awarded to Global Computer Enterprises, Inc. (GCE) to re-design the FPDS and to perform the operations and maintenance of the new system. All future data and reports will be available from GCE.

The FPDS Annual Report is no longer published and is only available at the FPDC website at www.fpdc.gov. This is the last report that will be prepared by the Federal Procurement Data Center Staff.

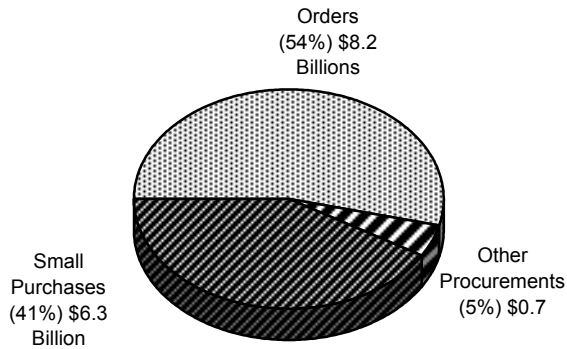
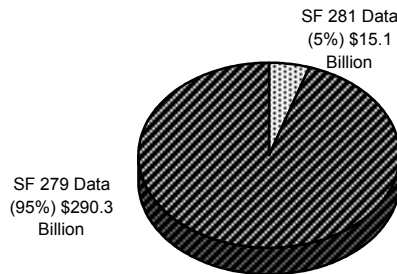


SF 281 Data By Procurement Methods

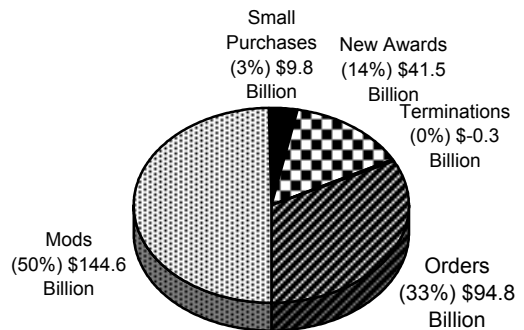


SF 279 Data By Kind of Contract Action

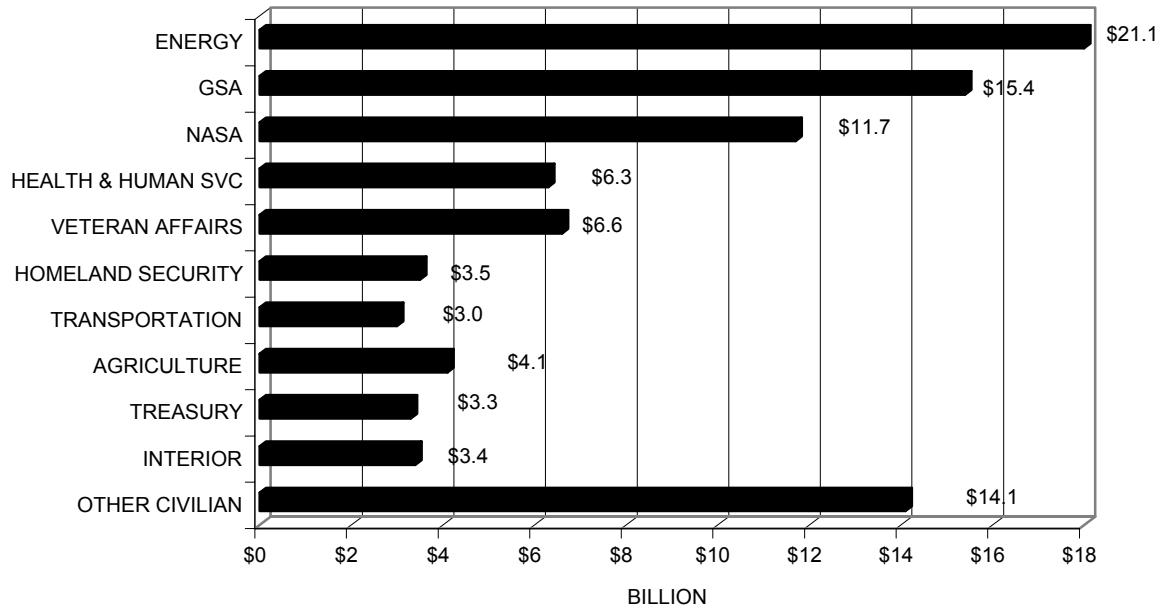

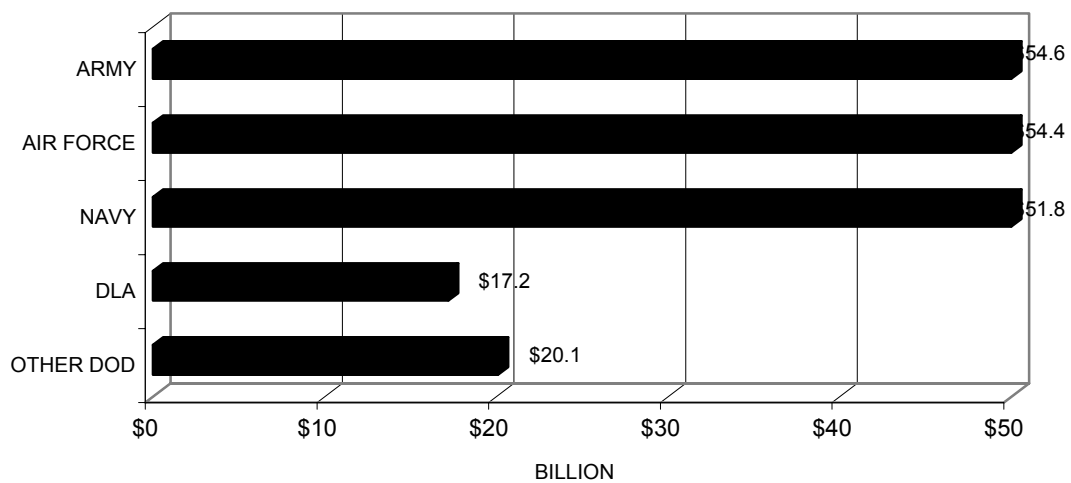

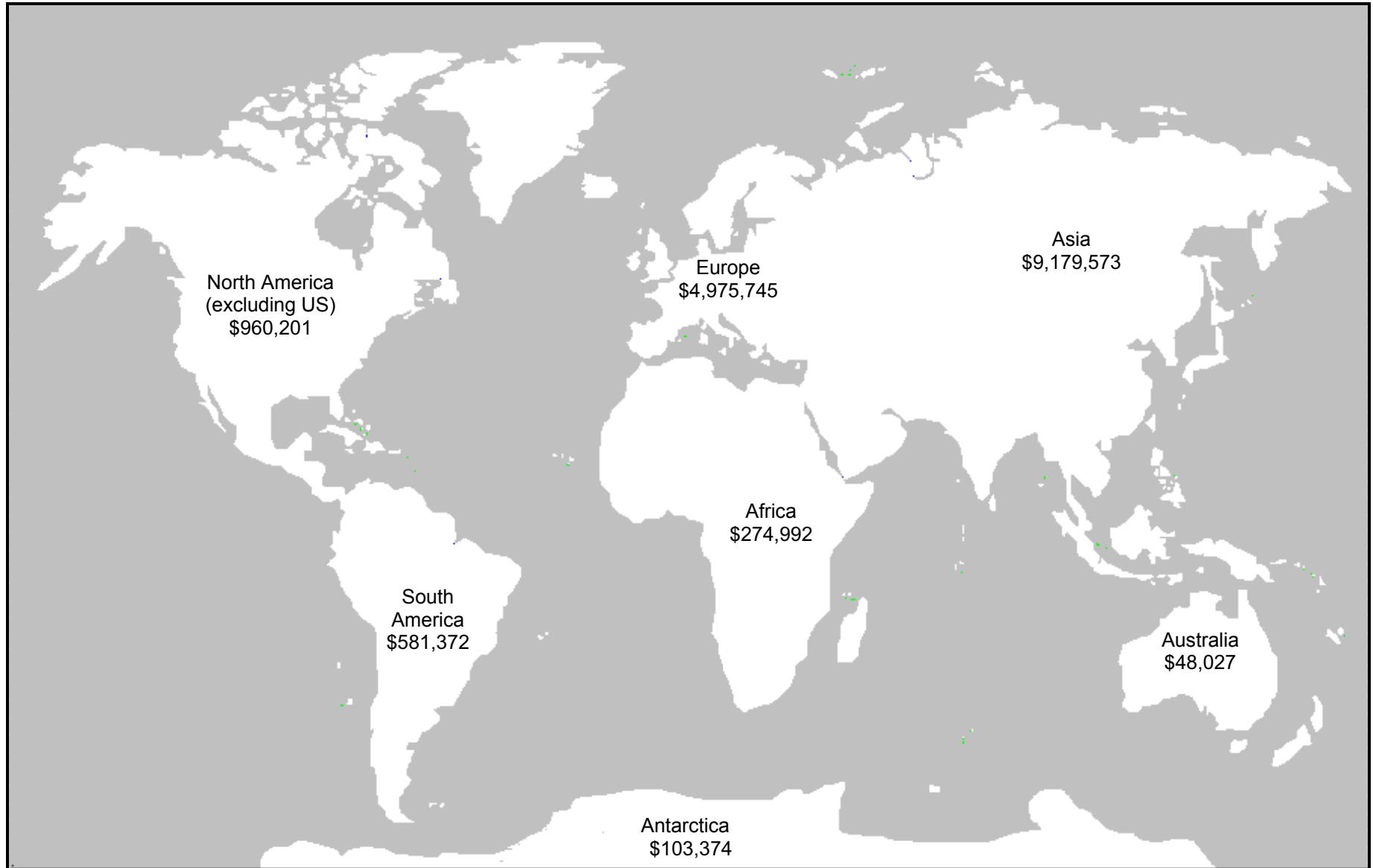
