State Exports & NAICS Data Added to USA Trade™ Online!

With the January 11th release of November merchandise trade data, the U.S. Census Bureau and STAT-USA® are pleased to announce the addition of state exports for HS and NAICS based codes to USA Trade Online!

What are State Exports?

Since 1987, the State of Origin of Movement Series has provided export statistics based on the state from which the merchandise starts its journey to the port of export. In more basic terms, the data reflect the transportation origin of exports. This information is published monthly by country of destination and method of transportation for 2-, 4-, and 6-digit HS and 3- and 4-digit NAICS based commodity classifications!

What are NAICS data?

The North American Industry Classification System (NAICS) was developed jointly by the U.S., Canada, and Mexico to provide comparable business activity statistics across North America. The system provides for similar data among the three countries up to the 5-digit level. USA Trade Online will offer state exports up to the 4-digit level.

NAICS replaced the Standard Industrial Classification (SIC) system in 1997 as the official classification system to be used by U.S. statistical agencies. The NAICS codes are based on broad industry groups, subgroups, and detailed groups of firms in similar lines of business. They include 1,170 industries, of which approximately 565 are service based, broken down into 20 two-digit sectors.

How to access the data?

Customers can access the new state export data from the Data Source Selection screen below the District and State level options. You will have to choose whether you're looking for HS or NAICS before proceeding as you cannot jump between the two classification codes. As with the port data, there are eight measures available with the state exports including containerized, air, vessel and total value.
