Dear Mr. Chairman:

In your April 25, 1996, letter, you asked us to respond to a number of questions concerning the District of Columbia's current financial condition and the efforts of the District of Columbia Financial Responsibility and Management Assistance Authority (Authority) to resolve the financial and management problems facing the District. You also asked us to look at actions taken by the control boards of New York City and Philadelphia-two cities that successfully overcame financial crises. In testimony given today before your Subcommittee, we provided our response to your request. This letter transmits additional information on the (1) recommendations made by the Authority in fiscal years 1996 and 1997 and (2) studies performed on each of the cities-the District, New York City, and Philadelphia-which we reviewed in our effort to respond to your request.

In enclosure I, we provide a list of the Authority's recommendations for fiscal years 1996 and 1997, which cover all aspects of the District's budget and operations. In performing our review of the Authority and the control boards of New York City and Philadelphia, we conducted extensive reviews of all the published information we could identify that described the nature of each city's financial and management problems and the related actions taken by each city's control board to resolve the problems. The published reports, testimonies, and other documents for the District of Columbia, New York City, and Philadelphia are listed in enclosures II, III, and IV, respectively.
