New Equipment and/or Instrumentation List Available July 1, 2003

The U.S. Department of Homeland Security (DHS), Office for Domestic Preparedness (ODP) and the U.S. Department of Energy, Office of Assets Utilization, National Center of Excellence for Materials Reuse (DOE) are pleased to announce the release of the Fiscal Year 2003 Fourth Quarter (FY03 Q4) HDER Equipment and Instrumentation List. This list includes information about the various types of equipment and/or instrumentation that is currently available through the HDER Program.

The FY03 Q4 HDER Equipment and Instrumentation List is accessible via the HDER Services Management Tool on the ODP secure web portal. Registered State Administering Agency (SAA) HDER Points of Contact (POC) who currently have a username and password account will have access to this list.

Enhancements to the HDER Services Management Tool on the Secure ODP Portal

The services request module for the HDER Services Management Tool includes a drop-down list menu which State Administering Agency (SAA) HDER Points of Contact (POC) should use to indicate which local jurisdiction(s) will be receiving HDER equipment. The services request module now also includes a text box that allows the SAA HDER POC to provide a description of the type of capability the requested equipment is intended to provide. This will allow ODP and DOE to ensure the state is obtaining equipment appropriate to the desired capability. Questions or additional comments about the services request may also be noted in this text box.

FY03 Third Quarter Services Requests

In the first month of its nationwide expansion, the HDER Program received requests from five states. During the third quarter of FY03, requests were received from Iowa, Georgia, Mississippi, Utah, and New

Mexico, none of whom were participants in the HDER Pilot Project. State HDER Point of Contact (POC) information is available on the ODP website (www.ojp.usdoj.gov/odp) under the HDER Bulletin section of the "Library" page.
