COMMITTEE ACTIVITIES IN AUGUST

Panel held its first teleconference in a series of three preceding the September 10-12 face to face meeting to review the Agency's draft Action Plan for the "Framework for Metals Assessment and Cross-Agency Guidance for Assessing Metals-Related Hazard and Risk." The Action Plan will lead to a Framework and Guidance for EPA programs to

use when assessing the hazards and risks of metals and metal compounds. The Action Plan (a) identifies the primary elements to be addressed in the assessment Framework; (b) proposes a structure for the Framework; and (c) sets out a process that will culminate in the production of the Guidance.

The panel received a briefing on ethics, discussed the charge and the review materials. Also, they were assigned to write specific charge questions and were briefed by Agency staff on the draft Action Plan. The chair noted that the panel is being asked to review a <u>plan</u>, not a finished procedure or document. Therefore, there is opportunity to provide constructive input that EPA can use to shape the framework and guidance.

n August 12, the Environmental Economics Advisory Committee (EEAC) met by public teleconference to come to closure on the consensus advice to be provided to the Administrator on the Committee's review of the Agency's methodology for evaluating "affordability" of new drinking water regulations to small systems. The concept of affordability was created by the 1996 amendments to the Safe Drinking Water Act and it is used to determine whether variances should be available to systems that provide drinking water to 10,000 or fewer customers (small systems).

The EEAC was asked by the EPA's Office of Ground Water and Drinking Water to comment on: a) the basic approach to determining affordability for small systems; b) factors included within the methodology; c) the application, focus, and definition of affordability; and d) whether the potential availability of financial assistance should be considered in the national level affordability criteria.

The Committee members came to closure on the advice to be given on each question. The report to the Administrator is now being developed by the Committee.

n August 15, the Executive Committee's Metals Assessment Panel held its second conference call in a series of three to allow the Panel to hear public comments and invited presentations. Because no public comment was requested, the core of the meeting consisted of five presentations and questions on them. The speakers were: 1) Dr. Sam Luoma, Senior Research Hydrologist USGS and Lead Scientist, CALFED Bay-Delta Program, Sacramento, CA; 2) Bill Adams, Principal Environmental Scientist for Rio Tinto; 3) Herbert Needleman, Professor of Psychiatry and Pediatrics, School of Medicine, University of Pittsburgh; 4) Joshua Hamilton, Associate Professor of Pharmacology and Toxicology and Director of Dartmouth Center for Environmental Health Sciences; and 5) John Maney, President of Environmental Measurements Assessment.

Dr. Maney, who had previously chaired the SAB's review of the Agency's Quality System and its Implementation, spoke on the Agency's Quality System and OMB Quality Guidelines on Information Quality as they relate to the Draft Action Plan. n August 29, the Executive Committee's Metals Assessment Panel held its last conference call in the three part series to allow panelists to identify points they think should be addressed in the Panel's report; panelists actually made their comments available, in writing, in advance of the call and they are posted on the SAB's website, http://ww.epa.gov/sab. This made it easier for other panelists to add to or correct those points. The discussion also helped the Agency identify areas where the panel could benefit from additional briefings at the face-to-face meeting.

Mr. Fred Butterfield joined the SAB staff on September 2. Immediately before joining EPA, Fred was detailed to the Committee Management Secretariat of the General Services Administration, where he worked closely with the Office of Homeland Security and the Office of Counsel to the President in establishing the President's Homeland Security Advisory Council.

Prior to joining EPA, he was a Special Assistant and Senior Technical Advisor to the Deputy Assistant Secretary for Policy, Planning and Budget in the Office of the Assistant Secretary for Environmental Management (EM) at the U.S. Department of Energy. While at DOE, Fred served as the principal Deputy DFO for the 250-member EM Site-Specific Advisory Board chartered under FACA.

Fred is an environmental engineer who served for sixteen years on active duty with the U.S. Navy before taking early retirement in 1994, when he began his civilian Federal employee career. He will be serving as the DFO for the Clean Air Scientific Advisory Committee.
