UNANIMOUS CONSENT AGREEMENTS

CONFERENCE REPORT TO ACCOMPANY S. CON. RES. 70

1.—Ordered, That at 11:30 a.m. on Wednesday, June 4, 2008, notwithstanding the absence of the official papers on the conference report filed in the House on May 20, 2008 and printed in the Congressional Record beginning on page H4217, and the Senate being in possession of the Senate official copy of the conference report to accompany S. Con. Res. 70, an original concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2009 and including the appropriate budgetary levels for fiscal years 2008 and 2010 through 2013, all statutory time be yielded back except for 15 minutes to be equally divided and controlled between the Chairman and Ranking member; provided, that upon the use or yielding back of that time, the Senate proceed to vote on adoption of the conference report at 11:45 a.m.; further, that if the Senate fails to receive a message that the House has adopted the conference report by Tuesday, June 17, 2008, the Senate adoption of the conference report be vitiated; further, that if the vote is vitiated, then the order of May 22, 2008, with respect to this measure be in effect. (May 22, 2008) (June 3, 2008.)

S. 3036 (ORDER NO. 742)

2.—Ordered, That relative to the motion to proceed to the consideration of S. 3036, a bill to direct the Administrator of the Environmental Protection Agency to establish a program to decrease emissions of greenhouse gases, and for other purposes, any time during adjournment or Morning Business count against cloture. (June 3, 2008.)

S. 1974

3.—Ordered, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (Mar. 31, 2008.)

4.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

5.—Ordered, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance.
