UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE TO ACCOMPANY H.R. 3221

1.—Ordered, That at 9:30 a.m. on Thursday, July 10, 2008, the Senate resume consideration of the House Message to Accompany H.R. 3221, an act to provide needed housing reform and for other purposes; provided, that prior to the vote on the motion to invoke cloture on the motion to disagree to the amendments of the House adding a new title and inserting a new section to the amendment of the Senate to H.R. 3221, there be one hour of debate equally divided and controlled between the two Leaders or their designees, with Senators permitted to speak for up to 10 minutes each and with the final 10 minutes controlled by the Sneator from Connecticut (Mr. Dodd).

Ordered further, That with respect to the motion to disagree to the amendments of the House adding new title and inserting a new section to the amendment of the Senate to H.R. 3221, the mandatory quorum under Rule XXII be waived.

Ordered further, That no further motions to refer be in order during the pendency of the House message. (June 19, 26, 27, July 8, 9, 2008.)
