UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE ON S. 1

1.—Ordered, That at 9:30 a.m. on Thursday, August 2, 2007, the Senate resume consideration of the amendment of the House to S. 1, an act to provide greater transparency in the legislative process; provided that there be two hours of debate prior to a vote on the motion to invoke cloture on the motion to concur; provided further, that the two Leaders be permitted to use their Leadership Time at the expiration of the two hours, with the Majority Leader speaking immediately prior to the vote on the motion to invoke cloture; further, that upon the use of all time, the Senate proceed to vote on the motion to invoke cloture.

Ordered further, That the mandatory quorum call under Rule XXII be waived with respect to the cloture motion filed on the motion to concur in the amendment of the House to S. 1. (July 31, Aug. 1, 2007.)

H.R. 976 (ORDER NO. 58)

2.—Ordered, That upon the disposition of the amendment of the House to S. 1, the Senate resume consideration of H.R. 976, an act to amend the Internal Revenue Code of 1986 to provide tax relief for small businesses, and for other purposes.

Ordered further, That with respect to the cloture motions filed on H.R. 976 and Amdt. No. 2530 offered by the Senator from Montana (Mr. Baucus), the mandatory quorum calls under Rule XXII be waived. (Aug. 1, 2007.)

FISA LEGISLATION

3.—Ordered, That when the Majority Leader or his designee introduces FISA legislation, the bills be considered as having received their first readings on the Legislative day of August 1, 2007. (Aug. 1, 2007.)

VETO MESSAGE ON S. 5

4.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (June 20, 2007.)
