### UNANIMOUS CONSENT AGREEMENTS

### H.R. 2642 (ORDER NO. 207)

1.—Ordered, That on Thursday, September 6, 2007, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 2642, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for

the fiscal year ending September 30, 2008, and for other purposes.

Ordered further, That when the Senate resumes consideration of H.R. 2642 on Thursday, the only amendments remaining in order be the following: Amdt. No. 2664 offered by the Senator from Vermont (Mr. Sanders), Amdt. No. 2262 offered by the Senator from Colorado (Mr. Salazar), Amdt. No. 2673 offered by the Senator from Ohio (Mr. Brown), Amdt. No. 2666 offered by the Senator from Kentucky (Mr. McConnell), and an amendment relating to conventions offered by the Senator from Minnesota (Mr. Coleman); provided, that the Senator from Kentucky (Mr. Bunning) be recognized to speak for up to 30 minutes; provided further, that there be 2 minutes of debate prior to a vote in relation to the Coleman amendment, with the time equally divided between Senators Coleman and Bunning, or their designees; further, that there be 2 minutes for debate equally divided and controlled in the usual form prior to a vote in relation to all remaining amendments; further, that upon disposition of the Coleman amendment, the amendment vote sequence be the following: Amdt. No. 2664, Amdt. No. 2662, Amdt. No. 2673, and Amdt. No. 2666; further, that these amendments be disposed of with no further debate or motions in order, except for the debate specified above; provided further, that the previous order relating to points of order remain in effect with respect to this bill; further, that upon disposition of all amendments, the bill be read a third time, and the Senate proceed to vote on passage of the bill.

Ordered further, That upon passage of the bill, the Senate insist on its amendment, request a conference with the House of Representatives on the disagreeing votes of the two Houses, and the Chair be authorized to appoint conferees. (Sept. 5, 2007.)

### H.R. 2764 (ORDER NO. 265)

2.—Ordered, That upon the disposition of H.R. 2642, the Senate proceed to the consideration of H.R. 2764, an act making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2008, and for other purposes. (Sept. 5, 2007.)
