UNANIMOUS CONSENT AGREEMENT

S. 1348 (ORDER NO. 144)

Ordered, That at 10:00 a.m. on Thursday, June 7, 2007, the Senate resume consideration of S. 1348, a bill to provide for comprehensive immigration reform, and for other purposes; provided that there be 1 hour for debate equally divided and controlled between the two Leaders or their designees, with the time to run concurrently with respect to Amdt. No. 1311, as modified, offered by the Senator from Oklahoma (Mr. Coburn) and the motion to invoke cloture on the substitute Amdt. No. 1150, offered by the Senator from Nevada (Mr. Reid); further, that no amendments be in order to Amdt. No. 1311 prior to the vote.

Ordered further, That upon the use or yielding back of time, the Senate proceed to a vote in relation to Amdt. No. 1311, that upon the disposition of Amdt. No. 1311, without further intervening action or debate, the Senate proceed to a vote on the motion to invoke cloture on Senate Amdt. No. 1150.

Ordered further, That Senators have until 10:30 a.m., on Thursday, June 7, 2007 to file second degree amendments.

Ordered further, That relative to the cloture motion filed on substitute Amdt. No. 1150, the mandatory quorum required under Rule XXII be waived. (*June 5, 6, 2007.*)

 "And in all cases of conference asked after a vote of disagreement, etc., the conferees of the House asking it are to leave the papers with the conferees of the other * * *." The House agreeing to the conference usually acts on the report before the House requesting a conference.
