## CONFERENCE REPORT TO ACCOMPANY H.R. 2669

1.—*Ordered*, That at 9:00 a.m. on Friday, September 7, 2007, the Senate resume consideration of the conference report to accompany H.R. 2669, an act to provide for reconciliation pursuant to section 601 of the concurrent resolution on the budget for fiscal year 2008; provided, that there be 75 minutes for debate remaining with the time equally divided between the Chairman and Ranking Member of the Committee on Health, Education, Labor and Pensions; provided further, that the Senate proceed to a vote on that conference report at 10:15 a.m., with no intervening action or debate.
