UNANIMOUS CONSENT AGREEMENTS

H.R. 1585 (ORDER NO. 189)

1.—Ordered, That on Wednesday, July 11, 2007, following Morning Business, the Senate resume consideration of H.R. 1585, an act to authorize appropriations for fiscal year 2008 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; provided, that the time until 11:30 a.m. be for debate only with respect to the motion to invoke cloture on Amdt. No. 2012, offered by the Senator from Virginia (Mr. Webb), with the time equally divided and controlled between the Chair and Ranking Member of the Armed Services Committee, or their designees, and with the 20 minutes immediately prior to 11:30 a.m. equally divided between the two Leaders, with the Majority Leader controlling the final 10 minutes; provided further, that at 11:30 a.m., the Senate proceed to vote on the motion to invoke cloture on Amdt. No. 2012, without further intervening action or debate.

Ordered further, That if a cloture motion is filed on Tuesday, July 10, 2007, on Amdt.

No. 2012, the cloture vote occur on Wednesday, July 11, 2007.

Ordered further, That with respect to the motion to invoke cloture on Amdt. No. 2012,

the mandatory quorum under Rule XXII be waived.

Ordered further, That germane second degree amendments to Amdt. No. 2012 must be filed by 10:30 a.m. on Wednesday, July 11, 2007. (July 9, 10, 2007.)

VETO MESSAGE ON S. 5

2.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (June 20, 2007.)

3.—Ordered, That with respect to H.R. 1, the Implementing the 9/11 Commission Recommendations Act of 2007, it not be in order to consider the conference report thereon if it contains the collective bargaining provisions that the Majority Leader has committed to drop. (July 9, 2007.)
