UNANIMOUS CONSENT AGREEMENTS

H.R. 1585 (ORDER NO. 189)

No. 2135, as amended, offered by the Senator from North Dakota (Mr. Dorgan), and that the Senator from North Dakota and the Senator from New Hampshire (Mr. Sununu) each control 10 minutes.

Ordered further, That at 9:30 a.m., the Senate proceed to vote in relation to Amdt. No. 2135. (July 12, 2007.)
