UNANIMOUS CONSENT AGREEMENT

S. 574 (ORDER NO. 25)

Ordered, That on Saturday, February 17, 2007, at 12 noon, the Senate resume consideration of the motion to proceed to S. 574, a bill to express the sense of the Congress on Iraq; provided that the time until 1:45 p.m. shall be equally divided between the two Leaders or their designees, with the Republican Leader in control of the time between 1:25 p.m.–1:35 p.m. and the Majority Leader in control of the time between 1:35 p.m.–1:45 p.m.; further, that at 1:45 p.m. the Senate proceed to a vote on the motion to invoke cloture on the motion to proceed to the bill.

Ordered further, That relative to the cloture motion filed on the motion to proceed to S. 574, the mandatory quorum required under Rule XXII be waived. (*Feb. 15, 16, 2007.*)
