UNANIMOUS CONSENT AGREEMENTS

H.R. 1585 (ORDER NO. 189)

1.—Ordered, That on Wednesday, September 19, 2007 at 9:30 a.m., the Senate resume consideration of H.R. 1585, an act to authorize appropriations for fiscal year 2008 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes.

Ordered further, That there be 60 minutes of debate prior to a vote on the motion to invoke cloture on Amdt. No. 2022, offered by the Senator from Michigan (Mr. Levin) to Amdt. No. 2011, with the time equally divided and controlled between the Leaders,

or their designees.

Ordered further, That upon the conclusion of the debate, the Senate proceed to vote on the motion to invoke cloture, with the mandatory quorum under Rule XXII being waived.

Ordered further, That Senators have until 10 a.m. to file any germane second degree amendments to Amdt. No. 2022. (Sept. 17, 19, 2007.)
