UNANIMOUS CONSENT AGREEMENTS

S. 2205 (ORDER NO. 431)

Ordered, That with respect to the cloture motion filed on the motion to proceed to S. 2205, the mandatory quorum call under Rule XXII be waived. (Oct. 22, 23, 2007.)
