UNANIMOUS CONSENT AGREEMENTS

H.R. 1585 (ORDER NO. 189)

1.—Ordered, That when the Senate resumes consideration of the Biden Amendment No. 2997, there be 30 minutes of debate equally divided and controlled between Senator Biden and Senator McCain, or their designees, prior to a vote in relation to the amendment, with no amendment in order to the amendment prior to the vote; provided, that the amendment be subject to a 60 vote threshold, and that if it does not achieve that threshold, the amendment be withdrawn. (Sept. 20, 2007.)

H.R. 1495 (ORDER NO. 128)

2.—Ordered, That at 3 p.m., on Monday, September 24, 2007, the Senate proceed to consideration of the conference report to accompany H.R. 1495, an act to provide for the conservation and development of water and related resources, to authorize the Secretary of the Army to construct various projects for improvements to rivers and harbors of the United States, and for other purposes; provided, that the time until 5:45 p.m. be divided as follows: 30 minutes under the control of the Senator from Wisconsin (Mr. Feingold), with the remainder of the time under the control of the two Leaders or their designees; provided further, that at 5:45 p.m., the Senate, without any intervening action or debate, vote on passage of the conference report. (Sept. 20, 2007.)

3.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.
