UNANIMOUS CONSENT AGREEMENTS

H.R. 1585 (ORDER NO. 189)

1.—Ordered, That on Tuesday, September 25, 2007, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 1585, an act to authorize appropriations for fiscal year 2008 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes.

Ordered further, That when the Senate resumes consideration of the Amdt. No. 2997, offered by the Senator from Delaware (Mr. Biden), there be 30 minutes of debate equally divided and controlled between Senator Biden and Senator McCain, or their designees, prior to a vote in relation to the amendment, with no amendment in order to the amendment prior to the vote; provided, that the amendment be subject to a 60 vote threshold, and that if it does not achieve that threshold, the amendment be withdrawn.
