

San Francisco District Electronic Bid Solicitations

*** Important Announcement For All Prospective Contractors ***

On 30 December 2005, the U.S. Army Corps of Engineers, Sacramento District, implemented a new procedure for posting all NEW solicitations. The Electronic Bid Solicitations (EBS) system is no longer used to post solicitations. The new system, called **Federal Technical Data System (FedTeDS)** <https://www.fedteds.gov>, is a web-based dissemination tool designed to safeguard acquisition-related information for all Federal agencies. All prospective contractors and their subcontractors and suppliers will be required to be registered in FedTeDS before they will be allowed to download solicitation information. You are urged to read the FAQs posted on the FedTeDS website to better understand this new process.

Solicitations Under Evaluation - Solicitations which are "Under Evaluation" will NOT be downloaded to the FedTeDS website. Status updates will be communicated through the contract specialist and any award results will be posted to FedBizOpps (<http://www.fedbizopps.gov>).

Synopsis - Any synopsis in EBS will not be posted to FedTeDS; however, the synopsis will continue to be posted in FedBizOpps. When the solicitation is issued, the solicitation will be available in FedTeDS.

Please note that you must be registered in Central Contractor Registration (CCR) (<http://www.ccr.gov>) before you can register with FedTeDS.

Registration instructions for FedTeDS are accessed through the FedTeDS website (<https://www.fedteds.gov>). Click on the "Register with FedTeDS" hyperlink. Interested firms should select the "Begin Vendor/Contractor Registration Process" option. The information listed below is required to register:

- Central Contractor Registration (CCR) Marketing Partner Identification Number (MPIN)
- DUNS Number or CAGE Code
- Telephone Number
- E-Mail Address

The process to download information from FedTeds is:

1. Find solicitation announcement in Fed Biz Opps (<http://www.fedbizopps.gov>).
2. Once you open the announcement on Fed Biz Opps, there will be a link to the Solicitation on FedTeds in the remarks section. Click on the link.
3. If you are a first time user you will have to register; if you are already registered, log in and open the solicitation.
4. Once you have the solicitation open you can begin downloading the various files to your location.

PLEASE NOTE THAT ALL FIRMS WHO WANT TO ACCESS THE SOLICITATION – BOTH PROSPECTIVE PRIMES AND SUBS – WILL BE REQUIRED TO BE REGISTERED WITH FEDTEDS, AND THEREFORE MUST BE CCR-REGISTERED, HAVE A MPIN, AND EITHER A DUNS OR CAGE CODE.
