first time after Mr. Foster's death. 105 In addition, Mrs. Clinton stated that she has never met and does not know Mr. Livingstone's mother. 106

- D. The Circumstances Surrounding the Preparation of the Insert Do Not Corroborate its Accuracy.
  - 1. Agent Sculimbrene Had No Independent Recollection of the Interview with Mr. Nussbaum or Preparing the Insert.

Agent Sculimbrene had no independent recollection of conducting the interview with Mr. Nussbaum or preparing the insert, much less the details of the conversation. Agent Sculimbrene believed that the statement he attributed to Mr. Nussbaum was accurate, because he would have had no reason to report it unless Mr. Nussbaum made the statement.

Agent Sculimbrene explained that there were no underlying notes because he routinely did not take notes when interviewing associates of the appointee during a background investigation. He added that if the interview was conducted in his office or by

phone and there were no inconsistencies with the  $SF-86^{110}$  or if the interview was totally unremarkable, it was his practice to type the insert without any notes.  $^{111}$ 

While there were no notes to corroborate the accuracy of Agent Sculimbrene's insert, the OIC discovered one additional document in which Agent Sculimbrene repeated the information, attributed to Mr. Nussbaum in the insert, that Mrs. Clinton knew Mr. Livingstone's mother. On January 11, 1996, nearly three years after he wrote the insert, Agent Sculimbrene wrote a memorandum to Supervisory Special Agent Brad Wambach concerning the role of the FBI's White House Liaison Office in the background investigation process. 112 In the memorandum, Agent Sculimbrene described Mr. Livingstone as "a political appointee. His mother and Mrs. Clinton are personal friends. 113

In addition, Agent Sculimbrene informed the OIC in an interview, that he is "pretty sure" that Mr. Livingstone told him, during a background investigation interview, that Mrs.

Clinton knew his mother. 114 This information, however, is not in

Agent Sculimbrene's signed FD-302 report reflecting his background investigation interview of Mr. Livingstone. 115

## 2. Mr. Nussbaum Had No Independent Recollection of the Interview with Agent Sculimbrene.

Mr. Nussbaum has consistently stated that he did not recall meeting with Agent Sculimbrene and did not have any information about Mr. Livingstone at that time in order to make the statement attributed to him in the insert. 116 Following the public disclosure of the insert on July 25, 1996, Mr. Nussbaum stated that he "never told Agent Sculimbrene, or anyone else, that the First Lady recommended Craig Livingstone for his position in the White House or that the First Lady knew Livingstone's mother."117 In an interview with the OIC, Mr. Nussbaum stated that he did not recall talking to Agent Sculimbrene about Mr. Livingstone, but acknowledged the possibility that he did. 118 Mr. Nussbaum explained that at the time that he allegedly spoke with Agent Sculimbrene in March 1993, he knew nothing about Mr. Livingstone. 119 However, Mr. Nussbaum stated that because of his

confidence in Mr. Foster and Mr. Kennedy and the absence of any negative comments regarding Mr. Livingstone, it is possible that he paid a compliment of some sort to Mr. Livingstone in March 1993. 120

3. Former White House Counsel's Office Detailee Francis Sobol Did Not Recall Being Interviewed by Agent Sculimbrene.

The insert also listed Francis Sobol, a long-time attorney with the Department of Education who was detailed to the Office of the White House Counsel during the Bush Administration and remained until September 30, 1993, as a person interviewed by Agent Sculimbrene. In an interview with the OIC, Mr. Sobol told the OIC that he knew Agent Sculimbrene but did not remember being interviewed by him about the background of Mr. Livingstone or any other employee of the White House Counsel's Office. Mr. Sobol reviewed the insert and denied the validity of the statement that "he has known the appointee as a co-worker in the same office for about a month" on the ground that he did not consider Mr. Livingstone to be a co-worker.
