## USCCR TO INVESTIGATE THE STATUS OF ELEMENTARY AND SECONDARY SCHOOL DESEGREGATION

Commission examines the state of government desegregation efforts

What: Meeting of the U.S. Commission on Civil Rights, an independent, bipartisan agency charged with monitoring and protecting civil rights

WASHINGTON, DC – The U.S. Commission on Civil Rights has assembled a panel of experts to discuss ongoing government desegregation efforts in elementary and secondary education. A half century after *Brown v. Board of Education* federal courts still supervise the desegregation efforts of an estimated 400 school districts nationwide and the U.S. Department of Justice is a party in many of those cases. Further, the U.S. Department of Education, through its Office for Civil Rights, is tasked with ensuring that school districts receiving federal funds comply with Title VI of the Civil Rights Act of 1964, frequently through the use of 441 (b) desegregation plans. This briefing complements recent Commission work examining the benefits of diversity in elementary and secondary education presented in the report: *The Benefits of Racial and Ethnic Diversity in Elementary and Secondary Education*.
