20	OPENING STATEMENT OF CHAIRMAN FEINSTEIN
21	Chairman Feinstein. The meeting of the Rules Committee
22	will come to order.
23	Today, this committee is conducting a hearing on budget
24	requests for the 110th Congress submitted by the Finance
25	Committee, the Foreign Relations Committee, and the Select

- 1 Committee on Intelligence.
- 2 We have a very limited time today, so I would like to
- 3 move quickly and review the quidelines which were provided
- 4 to all committees for a two-year biennial budget.
- 5 Currently, the Senate is operating under a continuing
- 6 resolution for the remainder of fiscal year 2007, frozen at
- 7 fiscal year 2006 levels. Therefore, the total funding goal
- 8 for each of the fiscal years, 2007, 2008, 2009, is 100
- 9 percent of the 2006 total budget authorized by S.Res. 50,
- 10 the Omnibus Committee Funding Resolution for the 109th
- 11 Congress. Salaries may be adjusted by the projected COLAs
- 12 in January of 2007, 2008, and 2009. In addition, each
- 13 committee will also receive ten percent in additional
- 14 administrative funds to be distributed in accordance with
- 15 the Senate floor colloquy between Majority and Republican
- 16 leaders on January 12, 2007.
- 17 But the bottom line is that the Rules Committee has
- 18 been mandated to mark up and report out an Omnibus Committee
- 19 Funding Resolution for the 110th Congress that will provide
- 20 an authorization within the limited funds of the
- 21 appropriations account, inquiries and investigations for
- 22 fiscal year 2007.
- 23 Most committees closely followed the guidelines in
- 24 funding requests for the upcoming two-year biennial period.
- 25 We congratulate them for that. However, three committees

1 came in above guideline levels. Each has a very compelling

- 2 case. So the task before us is not an easy one, and now I
- 3 would like to ask the Ranking Member if he has a comment he
- 4 would like to make at this time and then we will call up the
- 5 members.
- 6 Senator Bennett. Thank you very much, Madam Chairman.
- 7 I do not have any comment. You have covered the situation
- 8 very well and I look forward to hearing from our colleagues
- 9 as they make their case.
- 10 Chairman Feinstein. Thank you very much, Senator. As
- 11 always, I look forward to working with you.
- I would now like to ask the Chair and the Ranking
- 13 Member of the Intelligence Committee to come forward,
- 14 please, my committee. We will begin with the Chairman,
- 15 Senator Rockefeller.

- 1 STATEMENT OF HON. JOHN D. ROCKEFELLER IV,
- 2 CHAIRMAN, SELECT COMMITTEE ON INTELLIGENCE, AND
- 3 UNITED STATES SENATOR FROM THE STATE OF WEST
- 4 VIRGINIA
- 5 Senator Rockefeller. Thank you, Chairman Feinstein.
- 6 Vice Chairman Bond and I am are very honored to be before
- 7 you and we recognize we are under a limit of something like
- 8 12 seconds, so we will do our very best.
- 9 [Laughter.]
- 10 Senator Rockefeller. Some of you know firsthand the
- 11 Intelligence Committee is responsible for overseeing the
- 12 activities of a great deal, and we have, Chairman Bond and
- 13 I, have committed ourselves to being very, very serious
- 14 about oversight, which is a time-consuming, exacting science
- 15 which has to be conducted out of public scrutiny, and so
- 16 this has created certain situations.
- 17 In order to carry out this vital national security
- 18 matter, frankly, we have to be very diligent. Due to the
- 19 very highly classified nature of our work, we do not have
- 20 the luxury that other committees do where in addition to the
- 21 committee staff, they can use their own staff. That cannot
- 22 happen. My committee staff cannot know what is going on,
- 23 and so that creates a different situation.
- 24 As you may recall, a little over two years ago, the
- 25 Senate passed S.Res. 445, which among other reforms requires

- 1 the Intelligence Committee to hire one employee for each
- 2 member. That employee is called a designee. The passage of
- 3 that resolution was in response to the 9/11 Commission
- 4 critique that the Congressional oversight of the
- 5 Intelligence Committee was dysfunctional, and that is not a
- 6 happy word to use. So in S.Res. 445, it also required the
- 7 committee to add supplemental people to its budget to allow
- 8 for the hiring of 13 new positions. That was specifically
- 9 required.
- 10 As a result, the Rules Committee increased the
- 11 committee's salary baseline in the 109th Congress to fund
- 12 these 13 positions at an annual salary level of \$100,000
- 13 each. Now, in West Virginia, that is off the charts. Here,
- 14 that is not. The 2006 COLA-adjusted salary level,
- 15 therefore, is \$103,440.
- One requested increase of approximately \$405,000, which
- 17 is ours, over the next two years--two years only--is based
- 18 on our desire to increase the salary ceiling of liaison
- 19 staff to \$115,000. Why? So we can get them and so that we
- 20 can keep them and so that they can be the kind of people
- 21 that can really help us do our work.
- Why is such an increase necessary in addition to the
- 23 work they have performed? As the Chairman knows very well,
- 24 we have added on a whole series of study areas where we have
- 25 joined the two staff committees together to work together.

- 1 But this means there is a whole new aspect to their work.
- 2 They have taken on additional budget duties and programmatic
- 3 responsibilities in complex and very specialized areas of
- 4 the committee's work.
- 5 Additionally, this year, we have begun a series of five
- 6 staff study groups on the committee on issues ranging from
- 7 Iran to terrorist safe havens, to human intelligence
- 8 collection, to China, to all kinds of things. Our liaison
- 9 staffers form the backbone of these important groups. That
- 10 is new in our committee. That is new.
- 11 In order to attract and retain skilled individuals to
- 12 fill these positions, we honestly feel, looking at the
- 13 marketplace, that we have to be able to pay them \$115,000 or
- 14 else we are not going to keep them, and that is just the way
- 15 that works.
- I will close by providing the Rules Committee with two
- 17 documents, which I hope you have in front of you. The first
- 18 of these is a list of the hearings that we have held so far,
- 19 and that shows you sort of the intensity of the way we are
- 20 going at this. Vice Chairman Bond, or as I call him
- 21 sometimes Bishop Bond, wants this to happen as much as I do,
- 22 so we are very determined about that. As you will see, the
- 23 Intelligence Committee's tempo is very high, averaging two
- 24 to three hearings a week.
- 25 The second document shows current staff assignments in

1 the committee, which will help you to appreciate our duties

- 2 that are liaison staff are shouldering today. We have some
- 3 vacancies. We have some needs.
- 4 I thank you for your consideration of the Intelligence
- 5 Committee and would ask that the good Bishop speak.
- 6 [The prepared statement of Senator Rockefeller
- 7 follows:]

1 Chairman Feinstein. Thank you, my Chairman.

2 My Ranking Member?

1 STATEMENT OF HON. CHRISTOPHER S. BOND, RANKING
```

- 2 MEMBER, SELECT COMMITTEE ON INTELLIGENCE, AND
- 3 UNITED STATES SENATOR FROM THE STATE OF MISSOURI
- 4 Senator Bond. Madam Chair and Senator Bennett, my
- 5 apologies to Senator Bennett. He is the Bishop. I am just
- 6 an usher in my church.
- 7 [Laughter.]
- 8 Senator Bond. But I am here to support fully the
- 9 recommendation that Chairman Rockefeller has made.
- 10 Following what he said about the 9/11 Commission and S.Res.
- 11 445, we established the designee salary at \$100,000, going
- 12 up with the cost of living, and very importantly, the
- 13 Chairman and I have agreed that we are going to utilize
- 14 fully in the Intelligence Committee all of these designees
- 15 because they come with great backgrounds and we have a
- 16 tremendous workload and we are putting it on their backs.
- 17 The problem is that several members who had good
- 18 intelligence background clearance designees they wished to
- 19 hire could not hire them at \$100,000. It was my
- 20 recommendation to the Chairman, which he graciously and
- 21 wholeheartedly accepted, that we ask you to give us enough
- 22 room to pay a slightly higher salary to those designees who
- 23 warrant it to be able to keep them on our payroll and on
- 24 task.
- The average age of our designees is in the late 30s.

- 1 Now, \$100,000 buys you a senior GS-13 in the rest of
- 2 government, and with rapid promotion these days in the IC,
- 3 some there are making the GS-13 level with only six years'
- 4 experience. A hundred-and-fifteen-thousand dollars would
- 5 buy you a senior GS-14 with eight to 15 years' experience,
- 6 which is far more in line with the level of ability,
- 7 experience, and competency that our designees have.
- 8 So we respectfully request that you allow us the
- 9 additional headroom to pay those designees who we wish to
- 10 attract and keep a slightly higher salary of \$115,000. I
- 11 thank the Chair.
- 12 Chairman Feinstein. Thank you very much, Senator Bond.
- 13 Thank you, Senator Rockefeller.
- I believe the Ranking Member has no questions. I have
- 15 no questions. We are very grateful that you took the time
- 16 to be here. Thank you very much.
- 17 Senator Bond. Thank you very much.
- 18 Chairman Feinstein. We would ask that the Chairman and
- 19 Ranking Member or the relevant staff please come forward
- 20 from Foreign Relations. I know Mr. Blinken is here
- 21 representing Senator Biden, but I believe that he is not
- 22 going to testify, is that correct, Senator Lugar?
- 23 Senator Lugar. That is correct.
- Chairman Feinstein. And you will give the testimony--
- 25 Senator Lugar. For both of us.

1 Chairman Feinstein. --as Ranking Member. Fine.

2 Please proceed.

1	STATEMENT	OF	HON.	RICHARD	G.	LUGAR,	RANKING

- 2 MEMBER, COMMITTEE ON FOREIGN RELATIONS, AND UNITED
- 3 STATES SENATOR FROM THE STATE OF INDIANA
- 4 Senator Lugar. Madam Chairman and Senator Bennett and
- 5 members of the committee, it is a pleasure to be here to
- 6 testify on the Foreign Relations Committee budget requested
- 7 for the 110th Congress. Senator Biden deeply regrets that
- 8 he cannot be here today, but he has authorized me to speak
- 9 for him in making this presentation.
- 10 On behalf of the Foreign Relations Committee, Senator
- 11 Biden and I have submitted a request to the Rules Committee
- 12 for an amount that is roughly \$350,000 per year above the
- 13 amount suggested by the committee. As Senator Biden and I
- 14 stated in our budget submission, the Foreign Relations
- 15 Committee's request seeks to preserve in our regular budget
- 16 the additional funds that were granted to our committee out
- 17 of special reserves in the 109th Congress. Our funding
- 18 request--
- 19 Chairman Feinstein. Could I interrupt you for a
- 20 moment--
- 21 Senator Lugar. Yes, indeed.
- 22 Chairman Feinstein. -- just to make something clear.
- 23 You are already receiving that money this fiscal year.
- 24 Senator Lugar. That is correct.
- 25 Chairman Feinstein. So what we would do would

- 1 essentially be a continuation of that, is that correct?
- 2 Senator Lugar. That is correct, except it would now be
- 3 in the regular budget as opposed to the additional funds
- 4 which came from special reserves as given by the Rules
- 5 Committee in the 109th Congress.
- 6 Senator Bennett. If I could clarify, so that means
- 7 your baseline would change for future years?
- 8 Senator Lugar. Yes.
- 9 Senator Bennett. I see. Thank you.
- 10 Chairman Feinstein. That is what they are asking for.
- 11 Senator Lugar. True.
- 12 Chairman Feinstein. Please proceed.
- 13 Senator Lugar. Our funding request results from
- 14 careful consideration of the Foreign Relations Committee's
- 15 needs and a policy environment where foreign affairs issues
- 16 are far more prominent than they were a decade ago. My
- 17 conversations with other Senators indicates strong support
- 18 for expanding the Senate's role in national security policy.
- 19 This expansion of activity and oversight will depend greatly
- 20 on the capabilities of the Foreign Relations Committee.
- 21 During the last four years, by most statistical
- 22 measures, the Senate Foreign Relations Committee has been
- 23 the busiest committee in the Senate. We have held more
- 24 hearings and confirmed more nominees than any other
- 25 committee by a clear margin. During the last two

- 1 Congresses, the Foreign Relations Committee held 482
- 2 official hearings and meetings. No other committee came
- 3 within 100 of this total over the same period of time. Ir
- 4 fact, the Foreign Relations Committee held more meetings
- 5 than the combined total held by the Finance Committee, the
- 6 HELP Committee, the Environment Committee, and the Budget
- 7 Committee. All but 67 of our 482 meetings were full
- 8 committee hearings.
- 9 During the same four years, we confirmed 359 nominees,
- 10 again, the most in the Senate. Only two other committees
- 11 confirmed more than 150 nominees during that period. The
- 12 vast majority of our nominees are ambassadors, each of whom
- 13 require substantial vetting and a hearing that often serves
- 14 as the legislative branch's only review of United States
- 15 relations with that country over a three- or four-year span.
- In addition, we are the only Senate committee that is
- 17 charged with the responsibility for receiving foreign
- 18 dignitaries. Roughly 25 times a year, we host formal
- 19 meetings with visiting presidents, prime ministers, and
- 20 foreign ministers.
- 21 Our portfolio also includes all treaties that come
- 22 before the Senate. In the past four years, we have dealt
- 23 with treaties involving fisheries, airline regulation,
- 24 environmental protection, arms control, international
- 25 organized crime, nuclear power liability, bilateral

1 investment, taxes, terrorism, and extradition. Our staff

- 2 must be conversant in these and other subjects, not just
- 3 diplomacy and foreign policy.
- Beyond treaties, the committee has authored legislation
- 5 dealing with embassy security, nonproliferation, the Darfur
- 6 crisis, U.N. reform, Millennium Challenge Corporation, the
- 7 President's global AIDS bill, the enlargement of NATO, the
- 8 India nuclear deal, improved stabilization and
- 9 reconstruction capacity, global anti-corruption efforts,
- 10 protection for women and children in conflict zones, and
- 11 many other items.
- On top of our workload, Foreign Relations is the only
- 13 committee in the Senate that was expanded by three members
- 14 at the beginning of this Congress. The Senate leadership
- 15 made a decision that the demand for membership on our
- 16 committee warranted the additional members. Chairman Biden
- 17 and I accommodated their request and extra members have been
- 18 added. But more members bring greater staff demands, longer
- 19 hearings, and additional costs.
- The Republican Conference deems Foreign Relations to be
- 21 one of the four preeminent committees in the Senate.
- 22 However, despite its "super-A" status, the Foreign Relations
- 23 Committee does not have a "super-A" budget. The Foreign
- 24 Relations Committee has, by our estimate, just the tenth
- 25 largest budget among the 12 "A" committees plus the Budget

- 1 Committee. This situation does not exist because of a
- 2 carefully considered policy decision. Rather, it developed
- 3 incrementally over many years when the nation's attention
- 4 was focused on domestic policy.
- 5 When compared to the Armed Services and Finance
- 6 Committees, the other "super-A" committees funded through
- 7 the Rules Committee process, Foreign Relations is clearly at
- 8 a disadvantage. In the last Congress, the Armed Services
- 9 Committee, which possesses a nearly identical number of
- 10 staff slots as Foreign Relations and a similar need for
- 11 staff with top-secret clearances, had a budget that was more
- 12 than \$1 million larger on an annual basis. This amount
- 13 translates into roughly an additional \$20,000 per staff slot
- 14 for Armed Services above what Foreign Relations can offer.
- 15 I mentioned earlier the Foreign Relations Committee
- 16 held more hearings than four other major committees
- 17 combined. Three of the four committees have budgets that
- 18 are larger than ours, and the combine budgets are almost
- 19 five times greater than ours. We know of no historical or
- 20 practical justification for such a wide disparity between
- 21 funding and workload.
- We have not undertaken this work arbitrarily. The
- 23 demand for the information and oversight provided by these
- 24 hearings has been inexhaustible. Subjects like the
- 25 administration's strategy in Iraq, the six-party talks on

1 North Korea, international efforts to prevent Iran from

- 2 gaining nuclear weapons are existential issues for our
- 3 country that demand constant oversight.
- This year, in less than a month, we held 14 hearings on
- 5 Iraq. We anticipate that this extensive pace will continue
- 6 given our bipartisan plans for the committee and the dual
- 7 threats of war and catastrophic terrorism. Because of both
- 8 global and legislative context, we believe that at the
- 9 least, the Foreign Relations Committee should be granted the
- 10 funding we received last year and we are hopeful you will
- 11 find this request to be meritorious and will lend your
- 12 support to it.
- 13 I thank the Chairman and the Ranking Member for this
- 14 opportunity to testify and for your allowing me to go over
- 15 the limit to complete this testimony.

1 Chairman Feinstein. Thank you very, very much.

- I have no questions. Senator?
- 3 Senator Bennett. I have no questions.
- 4 Chairman Feinstein. Thank you.
- 5 Senator Lugar. Thank you very much.
- 6 Chairman Feinstein. Thank you very much, Senator
- 7 Lugar. We appreciate it.
- Now, we will hear from the Finance Committee. It is my
- 9 understanding that the Chairman is tied up in a meeting and
- 10 the committee will be represented by its esteemed Ranking
- 11 Member, Senator Grassley.

1	STATEMENT	OF	HON.	CHARLES	GRASSLEY.	. RANKING

- 2 MEMBER, COMMITTEE ON FINANCE AND A UNITED STATES
- 3 SENATOR FROM THE STATE OF IOWA
- 4 Senator Grassley. I have a statement here from Senator
- 5 Baucus, and you are right. He is in a meeting with Leader
- 6 Reid and so it is very necessary for him to be there and he
- 7 asked me if I would fill in and I am very happy to fill in.
- 8 I thank you very much for taking the time to be with us.
- 9 As Senator Rockefeller, who is also the second ranking
- 10 Democrat on our committee, the Finance Committee, as he was
- 11 walking out, he knew about the statements that we were going
- 12 to make to you and he asked if I would tell you that he
- 13 supported what Senator Baucus and I are asking for.
- 14 Chairman Feinstein. Thank you.
- 15 Senator Grassley. This is in regard also to
- 16 subcommittee funding. I had hoped, as in previous years, we
- 17 could have come to an agreement and avoided the need for a
- 18 hearing, but we are here. As my Chairman will point out in
- 19 his written statement, we are here on behalf of our
- 20 subcommittee leaders and we are only asking for what amounts
- 21 to 1.4 percent increase over our overall budget from last
- 22 year. That is about \$100,000 per year.
- 23 It may help to provide a little history to understand
- 24 where we are coming from. Up until the last Congress,
- 25 Finance was one of only two and maybe three committees that

1 didn't fund subcommittees. As Chairman the last four years,

- 2 the leadership--well, as Chairman just in 2005 and 2006 is
- 3 when this issue came up. The leadership persuaded me that
- 4 the committee should follow our conference rules and fund
- 5 subcommittees. So after discussion with Senator Baucus then
- 6 as Ranking Member, we agreed to see what we could do.
- 7 Our committee approved a request two years ago of
- 8 \$500,000 per year. We thought that that was a fair amount,
- 9 understanding personal offices would still have to
- 10 underwrite some of the costs of the various subcommittee
- 11 chairmen and ranking members. The Rules Committee at that
- 12 time came back and offered \$300,000 per year from a special
- 13 reserve.
- 14 So after some thought, Senator Baucus and I agreed that
- 15 that was a good start since it was all very new territory
- 16 for our committee anyway and for the members and how the
- 17 subcommittees were going to function. We felt if it
- 18 enhanced the committee, then we could, as we are now, come
- 19 back in the next Congress, asking for permanent funding like
- 20 all the other committees with subcommittees, get some kind
- 21 of an increased adjustment. I don't think anyone believes
- 22 that you can fund a whole subcommittee for \$30,000 to
- 23 \$40,000 a year. So that is the process which has brought us
- 24 here where we are today with this presentation. Again, the
- 25 request is really coming from our members.

I will give an example. Senator Hatch, who was Chair

- 2 and will now be Ranking Member on the Health Subcommittee,
- 3 has spoken to me a number of times about the need for this
- 4 request and both of you know him to be a reasonable and
- 5 fiscally conservative member, and, of course, he is not the
- 6 only one. I have had reference to some members saying that
- 7 they have spoken to you separately about this. I don't know
- 8 for sure, but that is what they have led me to believe.
- 9 We could be here asking for an overall committee
- 10 increase, since our committee hasn't been treated as well as
- 11 others in comparison to our responsibilities, and I will
- 12 give you a little statistics on that. We looked into the
- 13 Senate's legislative work a few years ago. We found that 25
- 14 percent of the legislation that actually took floor time
- 15 involved Finance Committee jurisdiction. If you think about
- 16 it, almost all of the major non-appropriation bills have
- 17 some kind of Finance Committee responsibility, whether it is
- 18 the minimum wage bill that we just recently went through or
- 19 the energy bill, the highway bill, the pension bill, the
- 20 last two years. The major bill we did in the lame duck
- 21 Congress included tax, trade, and health legislation.
- In this Congress, besides minimum wage, the energy,
- 23 education, and farm bills will likely have tax titles.
- 24 Visiting with energy people--I haven't visited with
- 25 education people, but we have all these education tax

- 1 credits, as an example, and seven of us are on the
- 2 Agriculture Committee for the farm bill. All of these are
- 3 likely to have tax titles to them coming up.
- 4 As a former Chairman, I tried to use subcommittees to
- 5 relieve some of the pressure on the committee, particularly
- 6 for hearings, and I think this is very dramatically going to
- 7 increase considering a very far-reaching agenda that
- 8 Chairman Baucus has spoken to me privately about and spoken
- 9 publicly as he addressed some of our hearings in his opening
- 10 statements. So I think that--and he mentioned this also in
- 11 the statement that you have there.
- 12 For instance, we have created an Energy and
- 13 Infrastructure Subcommittee, as just an example of some of
- 14 the things we are going to have to be working more
- 15 aggressively on because the new majority of the Congress has
- 16 made these very important issues that they want to deal
- 17 with, and they are issues that ought to be dealt with and
- 18 they are issues that I agree with Senator Baucus that we
- 19 ought to be tackling from the standpoint of our
- 20 responsibilities in those areas, and we are going to be
- 21 using subcommittees in this area to be helping us get ready
- 22 for those debates.
- 23 So in closing, I would ask that your committee
- 24 favorably consider our committee's appeal for more adequate
- 25 subcommittee funding.

1 [The prepared statement of Senator Grassley follows:]

1 Chairman Feinstein. Thank you very much, Senator.

- 2 Senator Grassley. Thank you.
- 3 Chairman Feinstein. My understanding when you came to
- 4 me on the floor, the request was \$400,000.
- 5 Senator Grassley. Yes.
- 6 Chairman Feinstein. And today, it is \$800,000, is that
- 7 correct?
- 8 Senator Grassley. No, \$300,000 a year--\$300,000 that
- 9 we got last year, \$100,000 more for this year, so \$400,000 a
- 10 year, and then to have that in the baseline so we don't have
- 11 to come back as we are now each time to get money out of the
- 12 special fund.
- 13 Chairman Feinstein. So the total request is \$400,000?
- 14 Senator Grassley. A year.
- 15 Chairman Feinstein. Okay. Do you have any questions?
- 16 Senator Grassley. But we would also like to have it in
- 17 the baseline so that we don't have to come back--
- 18 Chairman Feinstein. I understand. So would the other
- 19 committees.
- 20 Senator Grassley. Understand, we got \$300,000 last
- 21 time. We asked for \$500,000. We got \$300,000. I don't
- 22 think the subcommittees were satisfied with the way that
- 23 was, but it was a new operation for Senator Baucus and me,
- 24 and so we have had this practice, so we are saying \$300,000
- 25 plus \$100,000. In the overall budget, that is 1.4 percent

- 1 more money. We would then not have to ask for special
- 2 permission. And I would just emphasize, and I don't think I
- 3 have to emphasize for you, but this would only be the third
- 4 year that we would be funding subcommittees.
- 5 Chairman Feinstein. Right. I was confused, but I see
- 6 now in looking at the letter from you and Senator Baucus
- 7 that the \$800,000 which is in the letter is for two years.
- 8 Senator Grassley. Yes.
- 9 Chairman Feinstein. And so I would assume that is
- 10 where the \$400,000 is, \$400,000 a year.
- 11 Senator Grassley. Yes.
- 12 Chairman Feinstein. Okay, good. Do you have any
- 13 questions, Senator?
- 14 Senator Bennett. No, I have no questions. Thank you.
- 15 Chairman Feinstein. Thank you. I think that does it.
- 16 Thank you very much, Senator Grassley.
- 17 Senator Grassley. Thank you.
- 18 Chairman Feinstein. We appreciate it.
- 19 Senator Grassley. I appreciate the privilege of being
- 20 with you.
- 21 Chairman Feinstein. Thank you. I think there is no
- 22 further business to come before the committee, so it is
- 23 adjourned.
