SILVER IN FEBRUARY 2008

U.S. mines produced 90,600 kilograms (kg) of silver in February, an 8% decrease compared with January production of 98,300 kg. The daily production rate of silver in February was 3,100 kg, slightly less than the January production rate of 3,170 kg. The February daily production rate was 10% lower than the 2007 average production rate of 3,460 kg. Silver production in

the United States in February 2008 was 10% lower than February 2007 production of 101,000 kg.

Englehard Industries' silver price peaked at \$19.70 per troy ounce on February 29. The silver price averaged \$17.61 per troy ounce in February. This was a 26% increase from the average February 2007 price of \$12.94 per troy ounce.
