SILVER IN APRIL, MAY, AND JUNE 2008

U.S. mines produced 99,700 kilograms (kg), 90,900 kg, and 104,000 kg of silver in April, May, and June, respectively. In the second quarter of 2008, mines produced slightly more than that in the first quarter of 2008. Daily production rates were 3,320 kg, 2,930 kg, and 3,450 kg in April, May, and June, respectively. For the first 6 months of 2008, domestic mines produced 583,000 kg, 10% less than production in the first half of 2007.

The average Englehard Industries' silver price for the second quarter of 2008 was 2% lower than the average for the first quarter of 2008. For the second quarter of 2008, the price peaked at \$18.45 per troy ounce on April 16. The average price of silver in the first half of 2008 was 30% more than the average price in the first half of 2007.

Hecla Mining Co. (Coeur d'Alene, ID) announced the completion of the purchase of Rio Tinto plc (London, United Kingdom) subsidiaries Kennecott Greens Creek Mining Co. and Kennecott Juneau Mining Co. After the purchase, Hecla owned 100% of the Greens Creek Mine, near Juneau, AK. This purchase was expected to double Hecla's silver production to 342,000 kg annually and increase silver reserves by more than 150% (Hecla Mining Co., 2008).

Revett Minerals Inc. (Spokane Valley, WA) indicated that for the second quarter of 2008, its Troy Mine in Montana produced 15,300 kg of silver compared with production of 22,700 kg for the second quarter 2007. The Troy Mine has operated for 12 consecutive months without a lost-time accident (Revett Minerals Inc., 2008).

Compañía de Minas Buenaventura S.A.A. (Lima, Peru) announced that its Uchucchacua Mine produced 90,100 kg of silver in the second quarter 2008 compared with 67,400 kg of silver in the second quarter 2007. This is because of a 16% increase in recovery rates and a 14% increase in ore mined (Compañía de Minas Buenaventura S.A.A., 2008).
