That will culminate in the fielding of P2, our corporate automated information systems in April. With P2 on board and everyone trained on the business process, we will be poised to take advantage of the opportunities for better service that USACE 2012 presents.

In early July, we will be deeply involved in the Grand Excursion, a regional celebration of the original excursion 150 years ago. Our folks who work on the river will be responsible for assisting thousands of vessels navigate from the southern boundary of the district to St. Paul, Minn., and back. After that event, the Mississippi River Commission's annual low water inspection will be easy.

Lt. Gen. Bob Flowers will change command with the new chief of engineers sometime in the summer. That will impact some more than others, but there is always adjusting when new leaders come on board. And, speaking of new leaders, we will have a district change of command in late July. I will give you more details soon.

Lastly, the formation of the Gulf Regional Division in Baghdad will give some stability to our work in Iraq. There will be opportunities for service there in 120-day temporary duty, six-month temporary change-of-station and 12-month temporary change-of-station tours. With \$12 billion placement in construction for this year, there will be great things done for the people of Iraq by the Corps.

Those are the big events on the horizon. It's going to be a fast ride, so hang on!

# Nine from district support recovery from Hurricane Isabel

Nine volunteers from the St. Paul District deployed to support the Federal Emergency Management Agency with recovery efforts from Hurricane Isabel, October-December. The nine were: Tom Anderson, Patrick Duffney, Dave Ekstrand, Doug Kelly, Hubert Letourneau, Bob Schimming, Bill Stute, Keith Traynor and Duane Wilson. Seven of nine provided comments on their regular duties at MVP and their contributions to FEMA and the victims of Isabel. Debris removal was a major tasking for district personnel.

A national situation update on the FEMA web site provided the following recap of 2003 Atlantic Hurricane Season and Isabel. "The 2003 Atlantic hurricane season ended on Sunday, Nov. 30; and, according to forecasters, it was one of the busiest on record. The six-month season produced 14 named storms, including seven hurricanes .... The most damaging storm of the 2003 season was Isabel, packing 100 mph-winds when it made landfall in North Carolina. Isabel was the strongest hurricane to hit the United States since 1999. The storms during this year's hurricane season resulted in \$2.5 billion in losses, caused 62 deaths and at least 31 injuries requiring hospitalization."

A Sept. 23, 2003, FEMA situation update reported "Virginia remains the hardest hit in terms of power loss. About 950,000 customers are without power across the state."

**Tom Anderson**: Worked in the federal service for four years; lock operator at Lock and Dam 1, Minneapolis.

Experience with previous disasters: Environmental Protection Agency and Minnesota Pollution Control Agency.

Time in Virginia: Nov. 13-Dec. 20, 2003. Worked in Richmond.

Main duties: Monitored debris clean-up and contractor's truckloads.

Memory: "Most of the people were glad we were there and trying to get their property cleaned up. I received some good training and worked some long

hours. It was also interesting going through some backyards to assess the damage trees had done to telephone poles and lines."

**Patrick Duffney**: With the Corps for 26 years; works as a park ranger at Pokegama recreation area, Grand Rapids, Minn., and Winnibigoshish recreation area, Deer River, Minn.

Experience with previous disasters: Several. Time in Virginia: Nov. 17- Dec. 14, 2003. Worked in Hampton, Newport News, Norfolk and Virginia Beach. Main duties: Debris site-assessments and site monitoring.

Memory: "The local people seemed to appreciate our efforts. I also developed good working relationships with various contractors."

**Dave Ekstrand:** With the Corps 27 years; has worked at logistics management and in water control.

Experience with previous disasters: Eight.

Time in Virginia: Oct. 21-Nov. 19, 2003. Worked mostly in Richmond.

Main duties: Debris removal of a site of approximately 300 homes destroyed by a eight-foot surge of water from ... the James River, about 60 miles southeast of Richmond in Surry County.

Memory: "Escorting home-owners into the disaster area with the intention of locating valuables and keepsakes."

# Federal workers' guide to political participation

Now that election season is upon us, it is incumbent on all federal employees to know and abide by the rules for political activity. Below is a list of activities you may engage in if you wish and a list of activities prohibited by law.

Corps employees <u>may</u>:

- be candidates for public office in nonpartisan elections;
  - register and vote as they choose;
  - assist in voter registration drives;
- express opinions about candidates and issues;
- contribute money to political organizations;
- attend political fund-raising functions:
- attend and be active at political rallies and meetings;
- join and be an active member of a political party or club;

- sign nominating petitions;
- campaign for or against referendum questions, constitutional amendments, municipal ordinances;
- campaign for or against candidates in partisan elections;
- make campaign speeches for candidates in partisan elections;
- distribute campaign literature in partisan elections; and
- hold office in political clubs or parties.

**Doug Kelly:** With the Corps for 12 years; works in maintenance at Baldhill Dam, Valley City, N.D.

Experience with previous disasters: Yes.

Time in Virginia: Nov. 16-Dec. 14, 2003, in Hampton. Main duties: Received initial training in debris removal operations and private property assessment. Then, started working with contacts from the state of Virginia and the City of Hampton to inspect private property and determine which homes should be removed. Assessed about 50 homes a day; 30 had to be removed.

Memory: "I helped to expedite decisions between the state of Virginia and the City of Hampton regarding a home-owners' property. The home-owners were very pleased at the speed of the solution and the prevention of further damages."

**Robert Schimming**: Worked with the Corps 22 years. Is a permanent maintenance worker at Orwell Dam, Wheaton, Minn.

Experience with previous disasters: Debris mission in Grand Forks, N.D., in 1997.

Time in Virginia. Started duty Oct 19-Nov. 16. Worked in Richmond and Fredericksburg.

Main duties: Assigned to the Richmond area for the first week or so, then oversaw contractor operations in the Fredericksburg area and five other counties.

"I was tasked with working directly with the Virginia department of transportation or VDOT. VDOT was the main contact for overseeing the many contractors involved in this mission. I drove to where the contractors were loading and cutting up debris, and I spent a fair amount of time at the disposal area.

"On this mission the contractor was paid by the cubic yard hauled, so most all the disposal sites had a lift or platform ... to view cubic yards in each load. Prior to any loads hauled, the trucks were measured and given a cubic yard rating. There was also a number assigned to truck loads hauled and the percentage of load hauled. This information was then calculated and the total yards hauled were totaled, and the contractors were paid accordingly."

Main memory: "I was at a disposal site after I first arrived in the northern area. I noticed one of the trucks had a large cubic yard rating on the side. I asked to remeasure it. The load was largely overrated. We remeasured 15 trucks and all but one were overrated. The VDOT supervisor recalculated the actual cubic yards hauled back to the very first load by these trucks, which totaled nearly \$30,000 in repayment. Needless to say, I was not the most popular person with the contractor."

**Duane Wilson**: Worked with the Corps since 1978 with the exception of three years; works in maintenance at Lac Qui Parle dam, Watson, Minn.

Experience with previous disasters: Yes

Time in Virginia: Nov. 16-Dec.14, 2003 in Portsmouth and Hampton.

Main duties: Worked for FEMA the first two weeks to check for residential or roadside safety hazards.

Then, worked on private property assessments with Doug Kelly, state and city officials.

Memory: "I felt good in helping these people that had experienced this disaster and had lost a lot."

Corps employees may not:

- use official authority or influence to interfere with an election;
- solicit or discourage political activity of anyone with business before their agency;
- solicit or receive political contributions (may be done in certain limited situations by federal labor or other employee organizations);
- be candidates for public office in partisan elections;

- engage in political activity while:on duty;
- o in a government office;
- $\circ$  wearing an official uniform; or
- o using a government vehicle;
- wear partisan political buttons on duty.
