Dear Ms. McCaffrey:

USAID hereby amends subject Grant, originally awarded on September 26, 1996. This Amendment is made in accordance with Section 9 of the Standard Provisions of the Grant and under the authority of the Foreign Assistance Act of 1961, as amended, applicable regulations, and USAID policy. Except as specifically herein provided, all other terms and conditions of the Grant remain in full force and effect. Grant Amendment No. 31 is incorporated and made part of the Grant.

Grant Amendment No. 31 includes the attached supplemental program descriptions and modifies the budget to reflect the addition of FY 2006 funding as described below:

- A. A revision of the Grant Budget to reflect an increase of \$4,607,500 in FY 2006 funding from \$102,267,392, to \$106,874,892;
- B. A supplemental of the Grant Program Descriptions for the specific activities set forth in Attachment 3.

C. Provides \$4,607,500 in FY 2006 funding, as described below:

- \$126,000 (Field Support, CSP, NOA, USAID/AFR-SD) to UNICEF/WCARO to partially fund a polio programme communication officer.
- \$97,183 (Field Support, CSMN, NOA, USAID/E&E-DGST) to UNICEF/NY for Iodine Deficiency (IDD); \$47,183 Ukraine IDD; \$50,000 Ukraine Micronutrient Conference.
- \$75,000 (Field Support, CSMN, CO, USAID/E&E-DGST) to UNICEF/NY for Iodine Deficiency (IDD) in Ukraine.
- \$77,817 (Field Support, CSMN, REC, USAID/E&E-DGST) to UNICEF/NY for Iodine Deficiency (IDD) in Ukraine.
- \$1,642,000 (Field Support, CSP, NOA, USAID/India) to UNICEF/India to support Polio eradication activities.
- \$226,000 (Field Support, CSH, HIV, USAID/Nepal) to UNICEF/Nepal for the procurement of syringes.
- \$72,500 (MAARD, CSP, USAID/Nepal) to UNICEF/Nepal for the procurement of syringes.
- \$620,000 (MAARD, Malaria, USAID/Benin) to UNICEF/NY for the procurement of LLINs and RDTs.
- \$1,086,000 (MAARD, Malaria, USAID/Malawi) to UNICEF/NY for the procurement of LLINs.
- \$485,000 (MAARD, CSP, USAID/Afghanistan) to UNICEF/Afghanistan for support to Polio eradication activities.
- \$100,000 (MAARD, Malaria, USAID/Mozambique) to UNICEF/Mozambique to provide technical assistance to National Malaria Control Program.

This amendment is specifically set forth in the attached documents, and this grant is made on condition that the funds will be administered in accordance with the conditions set forth in the attached documents.
