The U.S. Army Corps of Engineers (USACE), Afghanistan Engineer District (AED) intends to issue a Request for Proposal (RFP) to award a Firm Fixed Price contract to design and construct one (1) Faculty of Higher Education (FoHE). AED intends to seek a proposal for the following locations: Balkh, Jawzjan and Faryab.

This project consists of the design and construction of new campus facilities for the Ministry of Education (MoE) to instruct teachers and trainers of teachers at the provincial level. The MoHE goal is to upgrade teacher qualifications and standardize certification levels of teachers in Afghanistan. The new facilities will provide the MoE with a source of continuing education in accordance with its long term goals.

The project includes components of design, material selection, labor, and equipment to construct buildings, parking, utilities and other infrastructure for the new FoHE buildings. The work within this contract shall meet and be constructed in accordance with International Building Codes (IBC), National Fire Protection Association (NFPA) 101 Life Safety Codes and security standards, and applicable local standards. Any standard that can be determined to be substantially equivalent to the standards specified in this document may be used. It is the Contractor's responsibility to show the equivalency of any alternate standard and the Contracting Officer must approve the alternate standards.

The applicable NAICS code is 236220. The contractor shall furnish his own labor, materials and equipment to accomplish the requirements. The estimated value of the contract is between \$1,000,000.00 and \$5,000,000.00. The total schedule for completing the entire work is 330 calendar days after receipt of notice to proceed.
