## Crooked Creek Lake Family Campground Rules

*In addition to United States Army Corps of Engineers Rules and Regulations (36 Code of Federal Regulations, Chapter III, Part 327) the following rules apply to the Crooked Creek Lake Family Campground.*

1. **Campsites are on a first-come, first-served basis.** In 2008, the campground will open at 9:00 a.m. on May 16 and close at 3:00 p.m. on September 7. To be a considered properly registered a camper is to complete the registration envelope with name, address, vehicle information and phone number; pay the proper fee; display their permit stub on their post and occupy the site. Persons with a valid *Golden Age/Access Passport* or *America the Beautiful Senior/Access Pass* are entitled to a 50% reduction in fees. The Pennsylvania Access Card is not applicable. Only persons 18 years of age or older may register a site. Checkout time is by 4:00 p.m. on the last day marked on the permit.
2. **One Primary Camping Unit** is allowed per site. For immediate families (up to 8 persons) with children under 22, or with parents **living under the same roof**, one additional small 2 or 3 person tent is allowed. **If you are a non-immediate family member**, you must register for another site or stay inside the primary unit. No second unit is allowed for you. In this scenario, a maximum of 8 persons are allowed per site. Organized groups wishing to stay in the Family campground require prior approval from the Park Manager.
3. In addition to their primary camping/sleeping unit (tent, pop-up, recreation vehicle, truck camper, etc.), **campers may have two additional vehicles** on their site. For those with a boat trailer, only one additional vehicle is permitted. In no situation will more than three of any combination be allowed. Contact a Park Ranger if you have questions.
4. Where a campsite is equipped with a gravel spur, all wheeled camping units/vehicles must be parked on the gravel spur. Visitors can park excess vehicle(s) in the overflow parking lot located outside the Family Campground.
5. **Possession or use of alcoholic beverages, fireworks and firearms is prohibited at all times.**
6. **Consideration of others.** Registered campers are responsible for the conduct of their guests. Guest are to leave the campground by the **10 p.m. to 8 a.m. Quiet Hours**. The use of generators during this period is not permitted. At all times, pets must be restrained on a maximum 6 foot leash, an owner must always be present and barking dogs can not be tolerated any time of day.
7. Parents must supervise their children on playground equipment. Playground use is from 8 a.m. until sunset. Bicycle riding is not permitted before sunrise or after dark. Bicycle operators must follow all helmet laws and guidelines. **Children under 12 are required to wear a helmet at all times.**
8. Swimming is at your own risk and only permitted at Tunnelville Beach. Registered campers are entitled to use the beach without paying the User Fee. Passes are issued by patrolling Park Rangers.
9. Please place all garbage in the dumpsters provided.
10. In addition to possibly being issued a citation, camping permits may be revoked at any time for violations of park rules and regulations. Credit vouchers for unused portion of permit will not be given if this occurs. **There are no refunds available.**
