SUBJECT: 2009 Federal Engineer of the Year Award Program – Request for Nominations

1. The purpose of this memorandum is to solicit your nomination of outstanding professional civilian or military engineer members of the U.S. Army Corps of Engineers (USACE) for recognition within USACE and the Federal Engineer of the Year Award Program. Nominations of civilian and military members must be received at HQUSACE by 24 October 2008.
2. A HQUSACE panel will select two U.S. Army Corps of Engineers awardees, one military and one civilian, for the USACE Engineers of the Year Award from the nominees forwarded by each MSC and separate office. These awardees will be the USACE nominees for the National Society of Professional Engineers (NSPE) Federal Engineer of the Year Award (FEYA) competition. An NSPE evaluation panel will select the "Federal Engineer of the Year". The individual agency award winners and the "NSPE Federal Engineer of the Year" will be honored at a ceremony to be held in February 2009 in Washington, D.C.
3. These programs provide a great opportunity to acknowledge formally the contributions of an outstanding civilian engineer and an outstanding military engineer from your MSC or separate office. In the past, USACE's nominations produced exceptional candidates for the awards. I urge you to take advantage of this opportunity.
4. Your nominees must be registered professional engineers (P.E. or E.I.T). Each MSC can provide one military and one civilian engineer nominee. All nominations must be typed on the official NSPE nomination form and submitted electronically to the POC below by COB 24 October 2008. To assure equal treatment for all, this deadline date will not be extended.
