IN
DEFENSE CONTRACTING**

The Memorandum of Understanding (MOU) between the Department of Defense of the United States of America and the Department of Defence of Australia and the Department of National Defence of Canada concerning Cooperative Implementation of Project Cost and Schedule Performance Management Principles in Defense Contracting dated 29th November 1995, will be amended as follows:

Section 1 paragraph (a) will be changed to read “in the case of Australia, “Defence Supplement to AS4817-2003 Project performance measurement using Earned Value” AND “AS4817-2003 Project performance measurement using Earned Value;”

Section 1 paragraph (b) will be changed to read “in the case of Canada, American National Standard/Electronic Industries Alliance ANSI/EIA-748 Earned Value Management Systems approved May 19, 1998 and reaffirmed August 28, 2002” AND "Canadian Government Standard CGSB 187.2-99 Project Performance Management"

Section 1 paragraph (c) will be changed to read "in the case of the United States of America, Department of Defense Instruction 5000.2, "Operation of the Defense Acquisition System;"

Pursuant to Section 9 this MoU will be extended for a further ten (10) years. This extension will enter into effect on 29 November 2005. This period may be extended with the mutual written consent of the Participants."
