If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Wetlands are in an area adjacent to Lake Murray, Lake Murray is an area that has a lot of growth. These wetlands have the capacity to trap sediments and pollutants from nearby roads and developments and help to regulate nutrients from adjacent uplands. These wetlands also act as flood storage during heavy rain events.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Site is a mixture of hardwoods and pine woodlands. Site has RPW-seasonals and a braided wetland system with associated pond. Hydrology is supplied by an intermittent stream which originates off-site, groundwater, and storm run-off. Wetlands are in an area adjacent to Lake Murray, Lake Murray is an area that has a lot of growth. These wetlands have the capacity to trap sediments and pollutants from nearby roads and developments and help to regulate nutrients from adjacent uplands. These wetlands also act as flood storage during heavy rain events. Tributary is an RPW-seasonal. Tributary flows directly into a TNW, Tributary has capacity to carry nutrients or pollutants to TNW, tributary has physical connection to TNW. Both the RPW-seasonal and abutting wetlands are considered jurisdictional due to a significant nexus determination.
