Four Hole Swamp then flows south by south west for approximately 10-15 miles, emptying into the Edisto River. The Edisto River is considered to be a Traditionally Navigable Water.

Summarize overall biological, chemical and physical functions being performed: Chemical – PFO wetlands have been proven to absorb both sediments and nutrients. The wetland labeled as wetland D on the surveyed plat is located in an area adjacent to Interstate 26. Additionally, the other similarly situated wetlands associated with the Non-RPW in which wetland D drains into, are located in an area adjacent to agricultural fields. These wetlands provide for important sediment and filtration functions for the downstream water by filtering out and absorbing both the road runoff, with associated pollutants, from Interstate 26, and remnant fertilizer and sediments associated with the agricultural fields. Physical – PFO wetlands have been proven to maintain seasonal flows and play a vital part in flood water storage. While the drainage area for this Non-RPW and these similarly situated wetlands is small in comparison to the entire watershed area of the Four Hole Swamp, this Non-RPW and associated wetlands do provide for some control of seasonal flows by providing floodwater storage for the near by RPW (Four Hole Swamp) as well as the downstream TNW (Edisto River). Biological – PFO wetlands provide for a natural habitat and breeding grounds for a multitude of species. In addition, wetlands provide for breeding grounds for species unable to successfully reproduce in fast moving waters and that move between wetlands and other waters throughout their life span. By doing so, the wetlands such as these similarly situated wetlands play a large role in maintaining populations of invertebrates, waterfowl and amphibians.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Physical – PFO wetlands have been proven to maintain seasonal flows and play a vital part in flood water storage. While the drainage area for this Non-RPW and these similarly situated wetlands is small in comparison to the entire watershed area of the Four Hole Swamp, this Non-RPW and associated wetlands do provide for some control of seasonal flows by

providing floodwater storage for the near by RPW (Four Hole Swamp) as well as the downstream TNW (Edisto River). Biological – PFO wetlands provide for a natural habitat and breeding grounds for a multitude of species. In addition, wetlands provide for breeding grounds for species unable to successfully reproduce in fast moving waters and that move between wetlands and other waters throughout their life span. By doing so, the wetlands such as these similarly situated wetlands play a large role in maintaining populations of invertebrates, waterfowl and amphibians. In terms of a surface hydrologic connection, the wetlands on site and the similarly situated wetlands are connected to the Four Hole Swamp by a Non-RPW. From the site the wetlands continue offsite to the north and drain into this Non-RPW. This Non RPW travels to the east and is culverted under the access road to the agricultural fields on the adjacent property to the north. From there this feature then flows to the north for less than a mile and empties into the Four Hole Swamp. During the day of the site visit flow was not seen with in the Non-RPW, however the visit was during the summer months and during a drought. Further more, even though no flow was seen during the site visit, the tributary in question was fully saturated with approximately 6” – 1’ of water in various locations along the feature. While this tributary is not a relatively permanent water, but rather a Non-RPW, it would not be unreasonable to conclude that water found in this tributary, has the potential to reach the downstream Traditionally Navigable Water (Edisto River). This is based on the fact that this tributary has an OHWM which shows evidence of flow and the tributary is in close proximity to a Perennial RPW (Four Hole Swamp). As these similarly situated wetlands have been shown to provide for many important functions and it has been shown that there is a surface hydrological connections, this wetlands are considered to have a significant nexus to the downstream TNW.
