If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Chemical – PFO1 wetlands have been proven to absorb both sediments and nutrients. These wetlands filter and absorb pollutants and sediments that drain into them from the adjacent uplands. Physical – PFO1 wetlands have been proven to maintain seasonal flows and play a vital part of floodwater storage. The wetlands on site catch the rain water runoff from the surrounding area and help to control seasonal flows by providing floodwater storage for both the near by seasonal RPW, for the near by perineal RPW (Cypress Swamp) and the downstream TNW (Ashley River). Biological – PFO1 wetlands have been proven to provide foraging grounds for snakes and amphibians that reside in the surrounding uplands. While not seen during the site visit, it would not be unreasonable to conclude that the wetlands on site provide foraging grounds for these animals..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

The significance of the wetlands can be broken down into three categories; chemical, physical and biological. Chemical – PFO1 wetlands have been proven to absorb both sediments and nutrients. These wetlands filter and absorb pollutants and sediments that drain into them from the adjacent uplands. Physical – PFO1 wetlands have been proven to maintain seasonal flows and play a vital part of floodwater storage. The wetlands on site catch the rain water runoff from the surrounding area and help to control seasonal flows by providing floodwater storage for both the near by seasonal RPW, for the near by perineal RPW (Cypress Swamp) and the downstream TNW (Ashley River). Biological – PFO1 wetlands have been proven to provide foraging grounds for snakes and amphibians that reside in the surrounding uplands. While not seen during the site visit, it would not be unreasonable to conclude that the wetlands on site provide foraging grounds for these animals.

Additionally, the tributary is shown as a blue line perennial stream on the USGS Topographic Maps. Taking this into account with all of the previously mentioned evidence, this tributary is at minimum a seasonal RPW by definition.
