If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide data and rationale indicating that tributary is perennial: **(The portion of the tributary which is located on site is the headwaters to the Perennial RPW depicted on both the USGS Topographic Maps and the NRCS Soil Survey Map)** The portion of the unnamed tributary located on site is believed to become a relatively permanent water body, with perennial flow offsite, however on site is believed to have only seasonal flow. The tributary offsite is classified as a perennial RPW based on the following evidence; The tributary is shown as a blue line perennial stream (offsite) on the USGS Topographic Maps and as a perennial stream (offsite) on the NRCS Soil Survey (Sheet # 45). This offsite portion of the tributary was not field verified, however with the fact that the tributary on site shows evidence of flow, and the fact that both the USGS Topographic maps and the NRCS Soil

Survey maps show this feature as a perennial RPW, it would not be unreasonable to conclude that the tributary has perennial flow.

- Tributaries of TNW where tributaries have continuous flow “seasonally” (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: The portion of the unnamed tributary located on site is believed to become a relatively permanent water body, with perennial flow offsite, however on site is believed to have only seasonal flow. The tributary on site is classified as a seasonal RPW based on the following evidence; The banks of the tributary in question are approximately 6 – 7 feet wide and the tributary is approximately 2 – 3 feet deep. Additionally, the tributary is shown as a blue line perennial stream (slightly further downstream) on the USGS Topographic Maps and as a perennial stream (slightly further downstream) on the NRCS Soil Survey (Sheet # 45). On top of this, the tributary has an Ordinary High Water Mark and the floor of the stream does not contain much/to any vegetation. During the day of the site visit water was present within the banks, pooling in some areas and with the entire stream bed being saturated. While flow was not observed on the day of the site visit, this area is in the midst of a long term drought that has affected water levels within many lakes and tributaries. With the fact that the tributary does not have much/to any vegetation within the bed, contains an OHWM and was significant enough for USGS and NRCS to consider it to be a perennial stream slightly further downstream, regardless of the fact that flow was not observed on the day of the site visit (due to the fact that this area is experiencing a prolonged period of drought), this portion of the tributary is considered to be a seasonal RPW.
