This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. pollutants which may influence the water quality of the downstream TNW. The tributary is also a source and conduit for carbon transport to the downstream TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The tributary provides the a filtering and/or transport system of poor quality water which comes from the upstream storm water treatment pond which collects runoff from commercial developments, parking lots, and roads and is likely to contain hydrocarbon pollutants. The tributary provides habitat and a travel corridor for terrestrial and aquatic species. It is also a source and transport mechanism for carbon which helps to support food webs in the downstream TNW.

seasonally: Based on evidence obtained via a site visit, shown in photographs in the file, it was determined that the RPW onsite is seasonal based on the presence of matted down and bent vegetation in the channel, also the presence of intermittent leaf litter and debris in the channel. The presence of a clear and natural depressed line provided evidence of flow greater than three months out of the year. Water staining below the OHWM also provided evidence that the feature is a seasonal RPW.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Based on evidence such as an OHWM, the presence of matted down and bent vegetation and intermittent leaf litter in the channel, as well as water staining on the bank below the OHWM, it was determined that the linear feature onsite is a seasonal RPW with a significant nexus between the RPW and the Waccamaw River, a TNW. The perennial RPW flowing offsite connects with Oakey Swamp, which then flows into Crab Tree Swamp, connecting with Kingston Lake. Kingston Lake is a known TNW which flows into the Waccamaw River, also a TNW. Photographs taken during a site visit are available in the file and represent the characteristics of the RPW which allow for classification as a seasonal RPW.
