This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The significance of the wetlands can be broken down into three categories; chemical, physical and biological. Chemical – PFO1 wetlands have been proven to absorb both sediments and nutrients. The wetlands on site are a part of a large drainage area that passes through this particular site. Pollutants and sediments that come from the residential streets, highways, and other wetlands drain into these wetlands and are absorbed and filtered out. Current and future construction around these wetlands will produce pollution and create sediments that will be absorbed and filtered by these wetlands. Physical – PFO1 wetlands have been proven to maintain seasonal flows and play a vital part of floodwater storage. The wetlands on site catch the rain water runoff from the surrounding area and help to control seasonal flows by providing floodwater storage for the downstream TNW (Edisto River) Biological – PFO1 wetlands have been proven to provide foraging grounds for snakes and amphibians that reside in the surrounding uplands. While not seen during the site visits, it would not be unduly speculative to conclude that the wetlands on site provide foraging grounds for these animals. With their location at the inception of a named swamp, these wetlands provide for essential wetland flood water storage and sediment/pollutant filtering for this drainage area. Due to this fact, these wetlands should be considered significant and that of noteable function. The nexus to a Traditional Navigable Water can be easily proven as the wetlands on this site are contiguous of the wetland system that is offsite and that is contiguous with Four Hole Swamp before its inception at the Edisto River down stream. Therefore the wetlands on site are jurisdictional by definition. The wetlands to the east and to the south of the site are connected to four hole swamp through a different path, this path is defined and discussed in a wetland determination adjacent to this property, SAC 2007-1478-2JV.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands on the west part of the site are part of the contiguous wetland system off site. This system is contiguous with Four Hole Swamp, a named Perennial RPW that connects directly with the Edisto River, a TNW. Since this system is directly connected and part of a wetland system directly connected to a perennial RPW down stream, named Four Hole Swamp, the wetlands on site are jurisdictional by definition. Wetlands on the east and southern portion of the property flow off to the other side of the property and are described in another JD SAC 2007-1478-2JV which includes a significant nexus determination for it's connection.
