C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This 33.11 acre site consists of two jurisdictional wetlands measuring 1.17 acres combined. These wetlands were determined to be jurisdictional by this office through a site visit, where it was observed that they flow off site and are contiguous with wetlands adjacent to property to the west. This system flows directly into Horlbeck Creek which is a TNW that drains into the Wando River. This site also contains 0.08 isolated wetland acres, as discussed in form 2 of 2. Additionally, there is a pond on the site that does not meet the criteria of a wetland and was verified in the field to have been dug out of uplands in efforts to obtain fill for the adjacent road construction. This pond does not connect to the wetland and was excavated in uplands.
