C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: **Review of topographic maps and aerial photographs confirmed that the wetland is jurisdictional.**

The topographic maps show a wetland signature as well as a solid blue line near the southwest corner of the property. Aerial photographs show a wetland signature down the northern property boundary which indicates that wetlands exist onsite. The NWI also provides evidence of this wetland signature. Soil surveys indicate hydric soils are present onsite. A site visit confirmed the presence of standing water as well as evidence of flow. This evidence confirmed that the site contained a linear feature which was determined to be a perennial RPW and wetlands directly abutting it. The topographic maps confirmed that nearby offsite, is a very prominent perennial RPW which flows into the Waccamaw River further downstream.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on an onsite inspection as well as supporting data from aerial photographs, topographic maps, and soil and NWI surveys it was determined that the RPW onsite was perennial. The presence of standing water and evidence of flow confirmed that the feature was perennial. Based on the presence of an OHWM, flow patterns indicated by well defined banks, and the presence of flowing water during an extreme drought event lead to the determination the RPW is perennial. The RPW flows through the wetland therefore the wetlands are directly abutting and contiguous to the RPW, as shown in photographs provided via the site visit. Aerial photographs confirmed this determination. A site visit was conducted to ensure that the wetlands were jurisdictional due to a previous site visit on a nearby site which yielded an isolated call. The wetlands and RPW onsite were determined to be jurisdictional and provided a connection to the Waccamaw River.
