DEPARTMENT OF THE TREASURY REPORT TO CONGRESS FY 2006 ACQUISITIONS FROM ENTITIES THAT MANUFACTURE ARTICLES, MATERIALS, OR SUPPLIES OUTSIDE OF THE UNITED STATES

Introduction

Section 837, Division A, of the FY 2006 Transportation, Treasury, Housing and Urban Development, the Judiciary, the District of Columbia, and Independent Agencies Appropriations Act, Public Law 109-115, provides the annual reporting requirements for the Buy American Act and requires submission of a report to Congress on the amount of acquisitions made by the agency from entities that manufacture the articles, materials, or supplies outside of the United States in that fiscal year.

Summary

1. Dollar value of articles, materials, or supplies purchased that were manufactured outside of the United States:

Response: The Department of the Treasury purchased 108 items totaling \$32,229,675 that were manufactured outside of the United States.

2. Itemized list of all waivers granted with respect to such articles, materials, or supplies under the Buy American Act (41 U.S.C. 10a *et seq.*):

Response: Per contract information contained in the Federal Procurement Data System, Treasury made 108 purchases of supplies for items manufactured outside of the United States in FY 2006.
