Explain: **This JD form consists of three non-jurisdictional wetlands that were delineated on-site. All three wetlands directly abut a human constructed tributary (ditch) that was determined to be a non-RPW. After viewing aerial photos, topographic maps, soil survey maps, National Wetland Inventory maps, and an onsite inspection, it was determined that the tributary (non-RPW) and all of its adjacent wetlands are absent of a significant nexus with the Pocataligo River (TNW). The human constructed non-RPW and adjacent wetlands have minimal ability to:**

Summarize overall biological, chemical and physical functions being performed: **These are palustrine forested wetlands. A large portion of these wetlands have been cleared. There is also a human constructed pond the 8.81 acre wetland. Therefore, these wetland systems possess very limited biological, chemical, and physical functions.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
