This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on an on-site inspection, aerial photos, and topographic maps, there are 7 small depressions surrounded by uplands within the site. W-1 (0.07 acres), W-2 (0.05 acres), W-3 (2.04 acres), W-4 (0.21 acres), W-5 (0.05 acres), W-6 (0.17 acres), and W-7 (0.12 acres). Each depression is surrounded by uplands with no surface connection to waters of the United States. The quad depicts this area as an old bay and mapped as coxville. The areas depicted as upland consists of a weak A horizon with 4

inches or less of a 10YR 3/1 surface with greater than 50% of uncoated sand grains. The wetland areas had a thick black surface with a thin muck layer in addition to water stained leaves, water marks on trees, and adventitious roots showing clear evidence of hydrology.
