C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on an on-site inspection, aerial photos, and topographic maps, there appear to be 4 small depressions surrounded by uplands within the site. W-1 (0.08 acres), W-2 (1.20 acres), W-3 (0.20 acres), and W-4 (0.59 acres). Each depression is surrounded by uplands with no surface connection to waters of the Umnited States. This site is mapped Coxville which is a hydric soil; however, as is typical for this soil series in the Pee Dee region, the areas that were determined to be upland demonstrated a

weak "A" horizon with more than 50% uncoated sand grains. The wetlands within this soil series are typical in that they possess a thick A horizon with a mucky modifyer just underneath the duff. The NWI maps also support onsite findings. The majority of the site is designated as upland pine, while the areas containing wetlands are designated palustrine forested. There are no surface connection to any waters or tributaries leading offsite that would indicate a nexus to a water of the US ..
