C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Jurisdiction for tributary was established by OHWM. Tributary was detemined to be an RPW by reviewing Topo maps, Horry County Soil Survey, aerial photos, and site visit under extreme drought conditions where water was observed flowing. Wetlands were detemined to be directly abutting contiguous by field verification and review of aerial photos, Horry County Soil Survey, HorryNWI, and Topographic maps. Jurisdiction for wetlands was established by 1987 Delineation Manual. in addition, the site contains 3 ponds excavated entirely of uplands non-jurisdictional .
