This ditch was also excavated entirely out of uplands and drains. This

was verified using the best available information (i.e. aerial photos, soil survey maps, NWI maps, and topo maps). There is also a previous jurisdictional determination on another property to the northwest in which the same ditch that runs along the north side of this property was determined to be non-jurisdictional.
