This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on an onsite inspection, it was determined that the wetlands onsite are isolated although the soil and NWI surveys, as well as topographic maps, and aerials provide evidence to the contrary. The Rapanos guidance does not allow for jurisdiction to be taken over the 2 isolated wetlands based on a the evidence obtained in the field. During the onsite inspection, wetland 2 was examined closely due to evidence of a possible connection to the Waccaamw River. Evidence was

observed of a linear feature which may have provided a nexus to wetlands on the adjacent property and therefore to the Waccamaw River. However, strong evidence of flow characteristics were not observed within the feature until approximately 20-30 North of the wetland line. Delineation flagging on the adjacent property connected to the linear feature at the edge of the property line where the feature was strong and also provided a connection to the Waccamaw River for the wetlands contained on the adjacent property. However, due to a lack of evidence of flow characteristics within the onsite feature, team members in Watershed 3 collaborated and determined that there was not enough evidence to prove the wetland pockets are jurisdictional.
