**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a site inspection on May 6, 2008 and May 19, 2008 it was determined that the wetland onsite is isolated. After careful review of the site, it was determined that the wetland did not show a connection to other WOUS. It was believed that the property to the south which contains the remaining portion of the wetland may have provided**

a connection. However, during an inspection of this property, now containing a subdivision named Moss Estates, it was determined that the pond system which allows drainage for the wetlands is not connected to any other waters of the US. The intake and outfall systems in the ponds did not provide any evidence of a connection via a roadside ditch or drainage into another water. A previous request (SAC 2003-39226) was reviewed to determine if the Corps had previous jurisdiction over this wetland system; there was no JD completed for this site because the subdivision did not require a permit since no fill was being placed in wetlands. Discussion with homeowners, as well as the President of the HOA and Secretary of the HOA, provided evidence that there is some flow regime which allows for water levels in the ponds to be maintained. However, no structure providing an outfall into another WOUS was observed. The President of the HOA also stated that they would be placing fish in the pond systems in the near future to cut down on algae levels in the ponds; thus providing evidence that limited flow is present. Other evidence of biological existence was observed. It was determined onsite that the only possible connection to other WOUS would be via overland sheet flow during a major storm event .
