**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: While aerial photographs, topographic maps, and soil and NWI surveys show that a connection to other WOUS may be present, it was deteremined based on a site visit that the wetland onsite is not connected to other waters of the US. There was evidence of upland cut ditches surrounding, as well as running through the property. These ditches did not provide evidence of flow, however they did contain water. They also did not have an OHWM or show evidence of**

intercepting ground water and any location. The property had also been clear cut so the presence of vegetation was limited. The adjacent property contained uplands directly abutting the ditch. As determined onsite, the only source of a connection to other WOUS would be due to overland sheet flow during a major storm event.
