C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of aerial photographs, Horry County Soil Survey, and NWI surveys, as well as a previous JD, it was determined that the site contained only uplands. A site visit confirmed that the adjacent site

possessed a ditch which was dug out of uplands and drained only uplands. The previous JD, SAC 84-97-1002 was a larger piece of property which contained 2 other parcels which have been sold off. The property, while both owned by the applicant, have differently TMS numbers and therefore were given 2 different SAC numbers.
