Explain: Based on an on site review, a review of soil survey data, aerial photography and the information provided by the applicant/consultant, the wetlands labeled as Isolated Non-Jurisdictional Wetlands No. 1 and No. 2 are considered to be isolated. This is

based on the fact that they do not have a surface, or apparent subsurface connection to any waters of the U.S. In reference to their distances from the nearest jurisdictional tributary, wetland # 1 is approximately 350 feet from Green Bay Branch and Wetland # 2 is approximately 570 feet from Green Bay Branch. Running through the center of this tract is an upland cut water feature. This feature shows no signs of water movement, and is surrounded on either side by an approximately 6 – 8 foot berm. This feature was cut out of uplands, drains only uplands and shows no significant signs of flow. Due to this, the feature will not be considered jurisdictional. Wetland # 1 is approximately 130' and Wetland # 2 is approximately 200' from this upland cut feature. However, with the fact that this upland cut feature is surrounded by a 6 – 8 foot continuous berm, no water exchange would be expected as overland flow, from either wetland to this feature. Additionally, the soil found in these wetlands is a thick clay which would greatly inhibit any subsurface flow from these wetlands to this upland cut feature. As this feature does not provide for a hydrologic connection, either by means of surface flow or subsurface flow, these wetlands are also considered to be isolated from this feature. In terms of a nexus to interstate or foreign exchange/commerce, these wetlands are small and located on private property and therefore do not have a perceivable nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
