connection to Pawley's Island Creek via any surface or shallow subsurface connection. The only available connection could be due to overland sheet flow during extreme storm events. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a site inspection, aerial photographs, topographic maps, and soil and NWI surveys, it was determined that the wetland onsite is isolated. There does not appear to be a connection to Pawley's Island Creek via a surface or shallow subsurface connection. Based on a site inspection it can be determined that there is lack of biological or chemical connections from the isolated pocket to the nearby water body. The wetland onsite is approximately 1 mile from the**

nearest OHWM or WOUS, therefore not allowing for a nexus from the wetland. Evidence from an adjacent site also supported the isolated call; the wetlands on the adjacent site were deemed isolated.
